AN ORDINANCE TO AMEND ORDINANCE NO. 2187-X, THE 1991-92 BUDGET ORDINANCE, PROVIDING A SUPPLEMENTAL APPROPRIATION FOR RELOCATION OF WATER MAINS FOR STREET IMPROVEMENTS CAPITAL ACCOUNT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$300,000 is hereby estimated to be available from the unappropriated balance of the Water and Sewer Operating Fund.

Section 2. That the sum of \$300,000 is hereby appropriated to the Water and Sewer Capital Improvement Fund 2071; 635.29 - Water Main Relocation for Street Improvements.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

AN ORDINANCE TO AMEND ORDINANCE NO. 2187-X, THE 1991-92 BUDGET ORDINANCE, APPROPRIATING FEDERAL AVIATION ADMINISTRATION GRANT AIP-37-0012-17 TO PROVIDE FUNDING FOR THE NC160 RELOCATION AND TERMINAL ROAD EXTENSION AND RUNWAY 36R EXTENSION SITE PREPARATION AND FOR THE AIRPORT'S HOME BUYOUT PROGRAM.

AN ORDINANCE ORDERING THE DEMOLITION AND REMOVAL OF THE DWELLING AT
1915 Baxter Street PURSUANT TO THE HOUSING CODE OF THE
CITY OF CHARLOTTE AND ARTICLE 19, PART 6, CHAPTER 160A OF THE GENERAL STATUTES
OF NORTH CAROLINA, SAID BUILDING BEING THE PROPERTY OF
Janie Ross RESIDING AT 1915 Baxter Street.

WHEREAS, the dwelling located at 1915 Baxter Street
in the City of Charlotte has been found by the Director of the Community
Development Department to be unfit for human habitation and the owners thereof
have been ordered to demolish and remove said dwelling, all pursuant to the

Department is hereby ordered to cause the demolition and removal of the dwelling
located at 1915 Baxter Street in the City of Charlotte in
accordance with the Housing Code of the City of Charlotte and Article 19, Part
6, Chapter 160A of the General Statutes of North Carolina.


