WHEREAS, the City Council of the City of Charlotte, North Carolina, has been petitioned under G. S. 160-452, as amended, to annex the area described herein, and

WHEREAS, the City Clerk has certified the sufficiency of said petition and a public hearing on the question of this annexation was held in the Council Chamber, in the City Hall, at 3:00 o'clock P.M., on the 12th day of August, 1968, and

WHEREAS, the City Council does hereby find as a fact that said petition meets the requirements of G. S. 160-452, as amended.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. By virtue of the authority granted by G. S. 160-452, as amended, the following described territory is hereby annexed and made part of the City of Charlotte, as of the 12th day of August, 1968.

Mallard Creek Township, Mecklenburg County, North Carolina BEGINNING at an iron, the northeasterly corner of Lot 47 of Hidden Valley #8 as shown in Map Book 12 at page 223 of the Mecklenburg County, North Carolina, Public Registry, said point also being on the westerly margin of Mt.
