WHEREAS, said owners have failed to comply with said order served by registered mail on the September 11, 1967 and October 9, 1967, NOW, THEREFORE,

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that the Superintendent of Building Inspection is hereby ordered to cause the demolition and removal of the dwelling located at 200 Victoria Avenue in the City of Charlotte in accordance with the Housing Code of the City of Charlotte and Article 15, Chapter 160 of the General Statutes of North Carolina.

AN ORDINANCE TO AMEND THE 1967-68 BUDGET ORDINANCE TO APPROPRIATE ADDITIONAL REVENUES RECEIVED IN THE POWELL BILL FUND.

WHEREAS, it was estimated that Powell Bill Fund revenues would total \$852,000, which together with the unencumbered balance of \$61,716 made a total Powell Bill Fund of \$913,716, and total State revenues received to date amount to \$906,079, thereby making possible a supplemental appropriation from these excess revenue receipts; and

WHEREAS, in order to properly maintain the streets of the City, the Engineering Department must make additional expenditures of \$49,105.50;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. That the 1967-68 Budget Ordinance be amended as follows:

(a) Under Section 2, the "Schedule F. Powell Bill Fund" will be changed to read "State Revenue" \$906,079, and the "Total Powell Bill Fund" be changed to read \$967,795.

(b) Under Section 1, "Schedule F. Powell Bill Fund - Street Improvements and Maintenance" will be changed to \$967,795.

Section 2. That \$49,105.50 of said appropriation be used for the purpose of purchasing equipment under Account 523.05.

Section 3. That this ordinance shall become effective upon its adoption.
