

AN ORDINANCE TO AMEND ORDINANCE NUMBER 4187-X, THE 2009-2010 BUDGET ORDINANCE AUTHORIZING AN INCREASE IN THE FY2010 INSTALLMENT PURCHASE CONTRACT FOR THE PURCHASE OF \$7,486,950 IN SOLID WASTE SERVICES ROLLOUT RECYCLING AND REFUSE CONTAINERS

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That Section 5 of the FY2010 annual ordinance 4187-X approved June 8, 2009 is hereby amended to reflect that the total sum of up to \$24,186,950 is estimated to be available from the proceeds of the FY2010 Installment Purchase Contract (Lease/Purchase). This increase of \$7,486,950 is for Solid Waste Services rollout recycling and refuse containers.
- Section 2. That Section 5 of the FY2010 annual ordinance 4187-X approved June 8, 2009 is hereby amended to reflect that the sum appropriated for the General Capital Equipment Fund is increased by \$7,486,950 to a total up to \$21,086,950.
- Section 3. All ordinances in conflict with this ordinance are hereby repealed.
- Section 4. This ordinance shall be effective upon adoption.



AN ORDINANCE TO AMEND ORDINANCE NUMBER 4187-X, THE 2009-2010 BUDGET ORDINANCE, APPROPRIATING FUNDING FROM THE STATE OF NORTH CAROLINA FOR BUSINESS INCENTIVES.

BE IT ORDAINED, by the City Council of the City of Charlotte;

Section 1. That the sum of \$1,200,000 is hereby estimated to be available from the State of North Carolina.

Section 2. That the sum of \$1,200,000 is hereby appropriated to the Life to Date Neighborhood Development Grants Fund for the One North Carolina Grant 6807 - 900.91.

Section 3. That the existence of the project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the program and funds are to be carried forward to subsequent fiscal years until all funds are expended.

Section 4. All ordinances in conflict with this ordinance are hereby repealed.

Section 5. This ordinance shall be effective upon adoption.



Section 1. That the sum of \$212,800 is available from the Telephone Commissions account (0101; 31045: 5461)


Section 2. That the sum of \$212,800 is hereby appropriated to the following:

Section 4. This ordinance shall be effective immediately.


