An Ordinance Amending the City Code
with respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-6MF, R-9MF, B-2 and I-1 to I-1 and I-2 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

Tract A, B-2 to I-2

Being property on the south side of Woodlawn Road from Nations Ford Road to General Younts Expressway.

Tract B, R-6MF to I-1

Being property on the west side of General Younts Expressway from Nations Ford Road to north of Wally Road.

Tract C, R-6MF to I-2

Being property bounded by Nations Ford Road, General Younts Expressway and the rear of lots on the north side of Wally Road.

Tract D, I-1 to I-2

Being property bounded by Nations Ford Road, Woodlawn Road, Southern Railroad an existing I-2 District Boundary near Lissom Lane and the Southern Crossline Railroad.

Tract E, R-9MF to I-2

Being property bounded by General Younts Expressway, Southern Crossline Railroad and an existing I-2 District Boundary from Springbrook Road to south of Ridgeway Road.

Tract F, R-9MF to I-1

Being property bounded by Nations Ford Road, General Younts Expressway and Ridgeway Road.

All the above tracts being more particularly described on the attached map which is made a part of this ordinance.

Section 2. That, this ordinance shall become effective upon its adoption.

AN ORDINANCE READOPTING AND CONTINUING IN FORCE CHAPTER 11, "LICENSES", OF THE CODE OF THE CITY OF CHARLOTTE TO PROVIDE FOR LEVYING, ASSESSING, IMPOSING AND DEFINING THE LICENSE AND PRIVILEGE TAXES OF THE CITY OF CHARLOTTE FOR THE FISCAL YEAR BEGINNING JULY 1, 1967, THROUGH JUNE 30, 1968.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. Chapter 11, entitled "Licenses", of the Code of the City of Charlotte is hereby readopted and continued in force, and as such constitutes the revenue ordinance of the City of Charlotte levying, assessing, imposing and defining the license and privilege taxes of the City of Charlotte for the fiscal year beginning July 1, 1967, and ending June 30, 1968.
