Section 1. That the sum of \$50,000 is hereby available from the General Fund- Assets Forfeiture Funds fund balance.


Section 2. That the sum of \$50,000 is hereby appropriated to the General Fund- Charlotte-Mecklenburg Police Department.

Section 5. It is the intent of this ordinance to be effective upon its adoption.



ORDINANCE NO. 1056-X

AN ORDINANCE AUTHORIZING THE CHARLOTTE-MECKLENBURG POLICE DEPARTMENT TO SEEK STATE ACCESS TO SBI / DCI CRIMINAL HISTORY RECORD INFORMATION FOR USE IN MAKING RECOMMENDATIONS CONCERNING THE SUITABILITY OF A PERSON OR OF A LOCATION FOR AN ABC PERMIT.

WHEREAS, North Carolina General Statute §18B-904(f) provides that the governing body of a city may designate an official of the city, by name or by position, to make recommendations to the State ABC Commission on behalf of the city concerning the suitability of a person or of a location for an ABC permit when the proposed location is within the city; and

WHEREAS, by Resolution dated July 17, 1995, the Charlotte City Council designated Deputy Chief R.L. Schurmeier of the Charlotte-Mecklenburg Police Department, as the City official authorized to make recommendations on behalf of the City of Charlotte concerning the suitability of a person or of a location for an ABC permit when the proposed location is within the City; and

WHEREAS, in order to make said recommendations, the Charlotte-Mecklenburg Police Department desires State access to the SBI/DCI Criminal History Record Information to obtain criminal history information on all persons applying for ABC permits for proposed locations within the City; and

WHEREAS, the Charlotte-Mecklenburg Police Department will obtain said criminal history information on each applicant based on the identification information regarding the applicant contained in the notice of permit application received from the State ABC Commission; and

WHEREAS, if said criminal history information reveals that an applicant has been convicted of any felony, a misdemeanor involving drugs or alcohol, or any offense in violation of Article 26 of Chapter 14 of the North Carolina General Statutes, the Charlotte-Mecklenburg Police Department will file a written objection to the issuance of the permit; and

WHEREAS, the State ABC Commission is the government agency responsible for the issuance of all ABC permits;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte that the Charlotte-Mecklenburg Police Department is hereby authorized to seek State access to the SBI/DCI Criminal History Record Information to obtain criminal history information on all persons applying for ABC permits for proposed locations within the City.

Section 1. That the sum of \$1,245,958 is hereby estimated to be available from the following sources:



ORDINANCE NUMBER: 1058

AMENDING CHAPTER 12, ARTICLE II, SECTION 12-16 OF THE CITY CODE

AN ORDINANCE INCREASING THE MEMBERSHIP OF THE CHARLOTTE MECKLENBURG COMMUNITY RELATIONS COMMITTEE FROM 30 TO 45

BE IT ORDAINED, by the City Council of the City of Charlotte, North Carolina, that:

Section 1. Section 12-16 of the Code of the City of Charlotte shall be rewritten to read as follows:

"Sec. 12-16. Creation.

(a) There is hereby created the Charlotte-Mecklenburg Community Relations Committee ("the committee") to consist of ~~thirty (30)~~ forty-five (45) members. Subject to the provisions of subsection (g) of this section, the mayor of the city shall appoint ~~five (5)~~ eight (8) members of the committee; the Charlotte City Council shall appoint ~~ten (10)~~ sixteen (16) members of the committee; and the Mecklenburg County Board of Commissioners shall appoint ~~fifteen (15)~~ twenty-one (21) members of the committee. The mayor and the chairman of the board of commissioners shall designate one (1) member as chairperson of the committee and one (1) member as vice-chairperson.

(b) The term of office for each member of the committee shall be three (3) years, except that a member whose term has expired may remain a member until his successor is appointed. A member chosen to fill a vacancy created by any cause other than the expiration of a term shall be appointed for the unexpired term of the member whom he is to succeed. A member of the committee is eligible for reappointment; provided, however, no person shall serve in succession more than two (2) full terms as a member.

(c) ~~Sixteen (16)~~ Twenty-three (23) members of the committee shall constitute a quorum for conducting all business of the committee, except as provided otherwise by law. Vacancies on the committee shall not impair the ability of the remaining members to exercise the powers of the committee, provided that the quorum requirement is met.

(d) A member of the committee may be removed by the mayor and chairman of the board of county commissioners for inefficiency, neglect of duty, misconduct or malfeasance in office, after being given a written statement of the charges and an opportunity to be heard thereon.

(e) Attendance of meetings and continued service on the committee by members appointed by the mayor shall be governed by the attendance policies established by the city council. Vacancies resulting from a member's failure to attend the required number of meetings shall be filled as provided for in paragraph (b) of this section.


(f) The committee may appoint persons or organizations to assist it for such terms and purposes as the committee may determine and may take all other actions necessary to carry out the powers and responsibilities granted and imposed by this article.

(g) The ~~seventeen (17)~~ thirty (30) persons who will be members of the committee as of July 1, ~~1995~~ 1998, shall remain members until their terms expire ~~on June 30, 1996~~. The Charlotte City Council shall appoint ~~eight (8)~~ six (6) new members, ~~and the Charlotte Mayor shall appoint five (5)~~ three (3) new members, and the Mecklenburg County Board of Commissioners shall appoint six (6) new members, with the term for each of the ~~thirteen (13)~~ fifteen (15) new members to begin on July 1, ~~1995~~ 1998. After June 30, ~~1996~~ 1998, the committee's membership shall conform to the requirements contained in subsection (a) of this section regarding the number of members to be appointed by each appointing authority."

Section 2. This ordinance shall be effective on July 1, 1998.
