

ORDINANCE NO. 523

AMENDING CHAPTER 6

AN ORDINANCE AMENDING CHAPTER 6, ARTICLE IV, OF THE CODE OF THE CITY OF CHARLOTTE RELATING TO PEDDLING IN THE CONGESTED BUSINESS DISTRICT.

BE IT ORDAINED by the City Council of the City of Charlotte that:

Section 1. Chapter 6, Article IV, Section 6-39, of the Code is hereby amended by the addition of the following language at the end of said section:

" ; provided, however, peddlers of produce or merchandise which has been grown, produced, made or manufactured by such person or members of such person's immediate family shall be permitted to peddle said produce or merchandise within the congested business district as part of a market, festival or similar event sponsored or sanctioned by the city or county government. "

Section 2. This ordinance shall become effective immediately.
