AN ORDINANCE ORDERING THE REMOVAL OF AN ABANDONED MOTOR VEHICLE LOCATED AT 2919 REID AVENUE PURSUANT TO THE ARTICLE 13-1.2 OF THE CODE OF CHARLOTTE AND CHAPTER 160-200 (43) OF THE GENERAL STATUTES OF NORTH CAROLINA.

WHEREAS, an abandoned motor vehicle located at 2919 Reid Avenue in the City of Charlotte has been found by the Supervisor of the Community Improvement Division of the Building Inspection Department to be unsafe and to constitute a health hazard, and the owners thereof have been ordered to remove said abandoned motor vehicle, all pursuant to the Article 13-1.2 of the Code of the City of Charlotte and Chapter 160-200 (43) of the General Statutes of North Carolina, and

WHEREAS, said owners have failed to comply with said order served by registered mail on September 22, 1969; and,

WHEREAS, the City Council, upon consideration of the evidence, finds as a fact that the aforesaid vehicle is unsafe and constitutes a health hazard;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that the Supervisor of the Community Improvement Division of the Building Inspection Department is hereby ordered to cause the removal of said abandoned motor vehicle located at 2919 Reid Avenue, in the City of Charlotte in accordance with 13-1.2 of the Code of the City of Charlotte and Chapter 160-200 (43) of the General Statutes of North Carolina.

ORDINANCE 423

AN ORDINANCE AMENDING CHAPTER 17, SECTION 52 OF THE CODE OF THE CITY OF CHARLOTTE.
