

ORDINANCE NO. 196-X

AN ORDINANCE TO AMEND SCHEDULES 1 and 1-A OF SECTION 20-60
OF THE CODE OF THE CITY OF CHARLOTTE RELATIVE TO PARKING
RESTRICTIONS.

BE IT ORDAINED BY the City Council of the City of Charlotte, North Carolina:

Section 1. Schedules 1 and 1-A of Section 20-60 of the Code of the City of Charlotte are hereby amended to establish the following parking restrictions:

- (1) "No Parking 7:30 A.M. to 9:30 A.M. and 4:30 P.M. TO 6:30 P.M.":

On the SOUTH SIDE OF FIFTH STREET from College Street to Church Street.
On ELIZABETH AVENUE from Kings Drive to Independence Boulevard.

- (2) "No Parking 7:30 A.M. to 9:30 A.M."

On the WEST SIDE OF COLLEGE STREET, from Stonewall Street to Third Street.

- (3) COLLEGE STREET, block by block, from Stonewall Street to Seventh Street, as follows:

- a. EAST SIDE from Stonewall Street to Third Street, "No Parking 7:00 A.M. to 6:00 P.M."
- b. EAST SIDE from Fourth Street to a point 80 +/- feet north, "No Parking Anytime".
- c. EAST SIDE from a point 80 +/- feet north of Fourth Street to a point 200 +/- feet north of Fourth Street, "No Parking 7:30 A.M. to 9:30 A.M., and 4:30 P.M. to 6:30 P.M."
- d. EAST SIDE from Trade Street to a point 120 +/- feet south, "No Parking Anytime".
- e. WEST SIDE from Fourth Street to Trade Street, "No Parking 7:00A.M. to 6:00 P.M."
- f. EAST SIDE from Trade Street to a point 110 +/- feet north, "No Parking Anytime".
- g. EAST SIDE from a point 110 +/- feet north of Trade Street to a point 210 +/- north of Trade Street, "No Parking 7:30 A.M. to 9:30 A.M., and 4:30 P.M. to 6:30 P.M."
- h. EAST SIDE from Fifth Street to a point 110 +/- feet south, "No Parking Anytime".
- i. WEST SIDE from Trade Street to Fifth Street, "No Parking 7:00 A.M. to 6:00 P.M."
- j. EAST SIDE from Fifth Street to Sixth Street, "No Parking 7:30 A.M. to 9:30 A.M. and 4:30 P.M. to 6:30 P.M."
- k. WEST SIDE from Fifth Street to Sixth Street, "No Parking 7:00 A.M. to 6:00 P.M."
- l. EAST SIDE from Sixth Street to a point 260 +/- feet north "No Parking 7:30 A.M. to 9:30 A.M., and 4:30 P.M. to 6:30 P.M."
- m. EAST SIDE from Seventh Street to a point 130 +/- feet south, "NO Parking Anytime".
- n. WEST SIDE from Sixth Street to Seventh Street, "No Parking 7:00 A.M. to 6:00 P.M."

- (4) CHURCH STREET -

- a. WEST SIDE from Seventh Street to Sixth Street, "No Parking 7:00 A.M. to 6:00 P.M."
- b. WEST SIDE from Sixth Street to Trade Street, "No Parking 7:00 A.M. to 6:00 P.M."
- c. EAST SIDE from Seventh Street to a point 100 +/- feet south, "No Parking Anytime", and from said point to a point 300 +/- feet further south, "No Parking 7:00 A.M. to 6:00 P.M."

- (5) FIFTH STREET
to
a. NORTH SIDE from College Street/a point 200 +/- feet west,
"No Parking Anytime".
b. SOUTH SIDE from College Street to railroad, "No Parking Anytime".
- (6) THIRD STREET
a. NORTH SIDE from College Street to a point 150 +/- feet west,
"No Parking Anytime".
- (7) SIXTH STREET
a. SOUTH SIDE from College Street to Brevard Street, "No Parking
Anytime".
- (8) FOURTH STREET
a. SOUTH SIDE from Southern Railroad Underpass to Brevard Street,
"No Parking Anytime".
b. BOTH SIDES from Caldwell Street to Alexander Street, "No Parking
Anytime".
c. BOTH SIDES from Myers Street to Hawthorne Lane, "No Parking
Anytime".
- (9) ELIZABETH AVENUE
a. BOTH SIDES from McDowell Street to Kings Drive, "No Parking
Anytime".
- (10) MCDOWELL STREET
a. BOTH SIDES from Fourth Street to Tenth Street, "No Parking Anytime".
b. WEST SIDE from First Street to a point 150 +/- feet south
"No Parking Anytime".
- (11) ELEVENTH STREET
a. BOTH SIDES from Tenth Street to Brevard Street, "No Parking
Anytime".
- (12) EAST TRADE STREET
a. NORTH SIDE from College Street to a point 160 +/- feet east,
"No Parking Anytime".

Section 2. The foregoing parking restrictions shall become effective upon the placing of signs giving notice thereof and the Traffic Schedules as referred to in Chapter 20 of the City Code, as promulgated by the Traffic Engineer and on file in the office of the City Clerk, as amended by this ordinance, are hereby adopted, confirmed and ratified.

Section 3. This ordinance shall become effective upon its adoption.
