

Section 1. That the sum of \$500,000 is hereby estimated to be available from a grant from the NCDOT Division of Aviation State Aid to Airports Grant Program.


Section 2. That the sum of \$500,000 is hereby appropriated to the Airport Capital Improvement Fund (2087 - 52935).

Section 5. This ordinance shall be effective upon adoption.



Section 1. That the sum of \$2,928,603 is available from Airport Excluded Centers Fund Balance.


