

A RESOLUTION OF THE CITY COUNCIL OF CITY OF CHARLOTTE CALLING FOR A JOINT PUBLIC HEARING TO BE HELD BY CITY COUNCIL AND CHARLOTTE-MECKLENBURG HISTORIC LANDMARKS COMMISSION ON THE QUESTION OF DESIGNATING THE PROPERTY KNOWN AS CHARLOTTE COLISEUM (ORIGINAL) AND OVENS AUDITORIUM (INCLUDING INTERIOR AND EXTERIOR OF THE CHARLOTTE COLISEUM (ORIGINAL), THE EXTERIOR OF OVENS AUDITORIUM AND TAX PARCEL NUMBER 159-028-01 UPON WHICH CHARLOTTE COLISEUM (ORIGINAL) AND OVENS AUDITORIUM ARE LOCATED) AS AN HISTORIC LANDMARK. THE PROPERTY, OWNED BY THE CITY OF CHARLOTTE, IS LOCATED AT THE SOUTHEASTERN CORNER OF THE INTERSECTION OF INDEPENDENCE BOULEVARD EAST AND COLISEUM DRIVE, CHARLOTTE, N. C.

WHEREAS, the Charlotte-Mecklenburg Historic Landmarks Commission has made an investigation and report on the historic, architectural, educational, and cultural significance of the property as described below; and

WHEREAS, the Charlotte-Mecklenburg Historic Landmarks Commission has recommended that the City Council adopt an ordinance designating the property described below as a historic landmark pursuant to Chapter 160A, Article 19, as amended, of the General Statutes of North Carolina; and

WHEREAS, the Charlotte-Mecklenburg Historic Landmarks Commission has determined that the property described below meets the criteria for designation because of special significance in terms of its history, architectural, and/or cultural importance, and because it possesses integrity of design, setting, workmanship, materials, feeling and/or association as required by N.C.G.S. 160A-400.5.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, Mecklenburg County, North Carolina, that the City Council and the Charlotte-Mecklenburg Historic Landmarks Commission will hold a joint public hearing at which time interested parties will have an opportunity to be heard on the question of the designation of the property known as the "Charlotte Coliseum (Original) and Ovens Auditorium" (entire interior and exterior of Charlotte Coliseum (Original), entire exterior of Ovens Auditorium, and the tax parcel of land upon which they are located) as an historic landmark.

BE IT FURTHER RESOLVED that reasonable notice of the time and place of the public hearing shall be given.
