A RESOLUTION AUTHORIZING THE  
REFUND OF CERTAIN TAXES

1. The City-County Tax Collector has collected certain taxes from the taxpayers set out on the list attached to the Docket.

3. The amounts listed on the schedule were collected through clerical error or by a tax illegally levied and assessed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, in regular session assembled this 26th day of March, 1984, that those taxpayers listed on the schedule of "Taxpayers and Refunds Requested" be refunded in the amounts therein set out and that the schedule and this resolution be spread upon the minutes of this meeting.

RESOLUTION DECLARING AN INTENT TO ABANDON AND CLOSE  
A PORTION OF PARK DRIVE BETWEEN OLD KINGS DRIVE AND INDEPENDENCE  
BOULEVARD IN THE CITY OF CHARLOTTE, MECKLENBURG COUNTY  
NORTH CAROLINA

WHEREAS, the Engineering Department of the City of Charlotte has filed a Petition to close a portion of Park Drive in the City of Charlotte, Mecklenburg County, North Carolina; and

WHEREAS, Park Drive petitioned to be closed lie between Old Kings Drive and Independence Boulevard as shown on map marked Exhibit "A" and and is more particularly described by metes and bounds in a document marked Exhibit "B", of which are available for inspection in the Office of the City Clerk, City Hall, Charlotte, North Carolina.

WHEREAS, the procedure for closing streets and public alleyways as outlined in North Carolina General Statutes, Chapter 160A, Section 299 requires that Council adopt a Resolution declaring its intent to close the street or public alleyway and calling a public hearing on the question; said Statute further requires that the Resolution shall be published once a week for four (4) successive weeks prior to the hearing, and a copy thereof be sent by registered or certified mail to all owners of property adjoining the street or public alleyway as shown on the County tax records, and a notice of the closing and public hearing shall be prominently posted in at least two (2) places along said street or public alleyway; and

WHEREAS, the City of Charlotte is desirous of complying with the Petitioner's request.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, at its regularly scheduled session of March 26, 1984, that it intends to close, said street being more particularly described on map and by a metes and bound description available for inspection in the City Clerk's Office, and hereby calls a public hearing on the question to be held at 7:30 p.m., on Monday, the 14th day of May, 1984, at Eastway Junior High School The City Clerk is hereby directed to publish a copy of this resolution in the Mecklenburg Times once a week for four successive weeks next preceding the date fixed here for such hearing, as required by N.C.G.S. 160A-299.




A RESOLUTION TO ESTABLISH THE UNIVERSITY OF NORTH CAROLINA AT CHARLOTTE, JOHNSON C. SMITH UNIVERSITY, AND THE MAIN LIBRARY, PUBLIC LIBRARY OF CHARLOTTE AND MECKLENBURG COUNTY, AS LOCAL GOVERNMENT DOCUMENTS DEPOSITORIES

WHEREAS, the responsibility of city government is growing, and there is a need for increased public awareness of its functions and services; and

WHEREAS, elected and administrative officials and the general public are often in need of accurate information pertaining to city government; and

WHEREAS, there is not now in Mecklenburg County a comprehensive library collection of city government publications; and

WHEREAS, the University of North Carolina at Charlotte Library, Johnson C. Smith University Library and the Public Library of Charlotte and Mecklenburg desire to serve as depositories for such collections;

NOW THEREFORE BE IT RESOLVED by the Charlotte City Council that the University of North Carolina at Charlotte, Johnson C. Smith University and the Public Library of Charlotte and Mecklenburg County are hereby designated as depositories for annual reports, serials, directories, minutes, and special reports of a general informational character, as deemed appropriate by the City Manager or his appointee, issued by the Charlotte Mayor and City Council or by any department, board, commission or authority created by the Charlotte Mayor and City Council; and

BE IT FURTHER RESOLVED that upon adoption the head of the originating agency, or his appointee, shall furnish and file with the University of North Carolina at Charlotte Library, Johnson C. Smith University Library, and the Public Library of Charlotte and Mecklenburg County one copy of such publications (one copy per library); and

BE IT FURTHER RESOLVED that the University of North Carolina at Charlotte Library, Johnson C. Smith University Library, and the Public Library of Charlotte and Mecklenburg County shall preserve this copy of such publications for the use and inspection of elected and administrative officials and the general public for a minimum of five years.

BE FURTHER RESOLVED that a copy of this resolution be sent to all department heads, boards, administrators, commissioners, and other heads of official bodies in Charlotte along with a letter of instruction concerning the collection of official publications.

AND BE IT FURTHER RESOLVED that this resolution shall take effect May 1, 1984 and include all official city documents of general informational character published after that date.
