#### I. Call to Order

Chair Krissy Oechslin called the meeting to order at 4:05 p.m.

#### Approval of May 2023 Meeting Summary

Chair Krissy Oechslin asked for a motion to approve the meeting summary from May 2023. Jarrett motion to approve the summary. Kevin seconded the motion. The May 2023 meeting summary was approved unanimously.

#### II. Public Comment on Agenda Items:

No public comment.

#### III. Progress Report Update

**Brent Cagle – Interim CEO (CATS)** - The Mayor and City Manager asked for a working group to be formed to look at specific issues related to CATS and to monitor those issues. The working group includes Council Member Driggs, Mayor

Pro Tem Winston, Council Member Anderson, Council Member Bokhari, as well as MTC members Mayor Bales and Mayor Higdon. Brent gave an update on the May 10<sup>th</sup> 2023 derailment and gave an update on the truck overhaul maintenance on the Blue Line fleet. Brent also gave an update on the bridge inspections and parking decks. He went over CATS staffing changes and the letters received from NCDOT.

### IV. Action Items:

### A. Proposed Changes to MTC Policies:

- a. MTC-05 Transit Markets
- b. MTC-06 Transit Service Guidelines

**Brian Horton – Transportation Planner (CATS) –** presented on the Travel Market & Transit Service Guidelines Proposed Policy Changes.

CATS Staff recommends the proposed changes to the MTC-05 and MTC-06 policies be approved and adopted by the MTC.

#### **Discussion:**

The performance standards are in this update. Not at a capacity threshold need right now to consider articulated buses. Seating configuration is not part of this. This specifically is about the size of the vehicle to the type of service. The seating capacity is something that CATS does with each order and has that flexibility to adjust as needed depending on the demand. Signal spacing destinations varies. Have some cleanup to do that will be part of Bus Stop Improvement Plan.

**Krissy Oechslin – Chair Transit Services Advisory Committee (TSAC) –** Krissy asked TSAC members if there is a motion to recommend the proposed changes to the MTC-05 and the MTC-06 policies to be approved and adopted by the MTC.

Sam approved and Jarrett seconded the motion. Krissy, yes. Kevin, yes. Bob, yes. Antonette, yes. Leroy, yes.

Motion is approved.

#### V. Information Items:

### A. CTC Redevelopment NEPA

**Monifa Woodside – Project Development Manager (CATS)-** presented the Charlotte Transportation Center Redevelopment Update: Environmental Process & Potential Bus Routing Scenarios.

**Bruce Jones – Transportation Planner (CATS) –** gave an overview of CATS bus network concepts that CATS is thinking for future and permanent facilities.

### **Discussion:**

The goal of route consolidation is to merge two routes in terms of the number of operators, the vehicles, frequency, and service hours. Still early in the process and will work with scheduling team to test out scenarios. Planning around Envision My Ride with no routes that have a frequency of more than 30-minutes and a number of routes with 15-minute or better service. Did an analysis with buses sharing bays and that would only give roughly around seven to ten minutes in terms of a layover. It would be tight if buses shared bays. CATS is trying to invest in other hubs instead of just the CTC.

Bus Stop Improvement Plan presentation will be moved to July's TSAC meeting.

### **B. Transit Ambassadors**

Jennifer Fehribach – General Manager Bus Operations (CATS) – presented a quick overview and summary of the Ambassador Program.

### **Discussion:**

The decisions on which routes and what times are based on the safety and security data. CATS will trend the routes and the Ambassadors are put onto those challenging routes that CATS may see a spike in escalated occurrences. The customers don't know when or where staff will show up. This is in addition to what is in the pipeline with CATS security that will also be riding the buses. Finally catching up with the contracts and filling the positions.

#### C. Proposed 74x Discontinuation

**Pamela White – Service Planning Manager (CATS) –** gave a presentation on Proposed Discontinuation: 74X Union County Express.

### **Discussion:**

The most utilized stop for that group is the Matthews Park & Ride for the 64X. Number of trips will increase combining the 64 & 65 and there will be more frequent service. Roughly around 300 spaces so plenty of room for CATS owned park & ride. CATS has been engaging with the towns and the City of Monroe. CATS needs a funding partner, and the funding partner does not need to be Union County but could be a jurisdiction.

### VI. Service Planning Manager Report:

**Pamela White – Service Planning Manager (CATS) –** There will be additional passenger surveys.

### VII. Chair Report:

**Krissy Oechslin – Chair Transit Services Advisory Committee (TSAC) –** Krissy asked TSAC members availability in July and August to hold TSAC meetings. No plans to cancel July or August TSAC meeting.

#### VIII. Service Issues:

Krissy saw the QR codes at the CTC for the CTC survey.

The meeting was concluded and adjourned 5:45pm.



## **PROCESS TO IDENTIFY INITIAL IMPROVEMENT BATCH**

- Filtered list to remove stops that will be improved through other projects
  - Land Development, streetscape improvements, road projects, etc.
- Prioritized stops based on the following:
  - Does not currently have an amenity in place
  - Does not currently have a boarding area
  - Ridership
  - Customer requests, etc.
  - Geographic distribution (Towns, Council Districts)
- Initial list for FY 23 consists of 30 stops (25 stops in Charlotte and 5 in Towns)
  - 26 stops will be upgraded to accommodate a shelter
- Identifying 60 additional stops for the next round of improvements
- Will continue to add to list and develop plans for the upcoming FY's





### PROCESS TO IDENTIFY INITIAL STOPS FOR SHELTER REPLACEMENT


- Filtered list to remove stops that will be improved through other projects
  - Land Development, streetscape improvements, City projects, etc.
- Identified shelters that are currently in poor condition
  - Based on assessment provided through Facilities
  - Shelters were ranked on a scale of 1-4, with 1 indicating poor condition
  - Included stops that received a score of 2 or less
- Prioritized locations based on the following:
  - Ridership
  - Customer requests, etc.
  - Condition
- Initial list includes 30 stops
- Will continue to add to list and develop locations for the upcoming FY's

# **Solar Lighting Pilot**

- "Urban Solar" lighting at bus stops
- Opportunity to pilot units in the field
- Will function as "push to activate"
- Emits light in any direction CATS sets





## ADDITIONAL BUS STOPS IMPROVEMENTS STRATEGIES

- Seeking additional funding through CRTPO and other grant sources
- Align bus stop improvement list with jurisdictional priorities.
- Bus stop consolidation plans
  - Start with Uptown stops, Express routes and recommendations from EMR for six priority corridors
  - Microtransit focused stops

- Signage replacement in Uptown Charlotte
- Eye level display removal






## 74X Union County Express Discontinuation Update

# 74X Union County Express

- Per MTC Policy, Union County and CATS jointly fund the 74x
- Current service is two morning and two evening trips
- Park and Rides
  - Monroe Crossing Mall Park and Ride
  - Union Towne Center Park and Ride



# 74X Union County Express

On April 17, 2023, the Union County Board of Commissioners voted to no longer fund their portion of the 74X bus service.


On April 19, 2023, Union County requested that CATS begin the process to discontinue the 74X Union County Express bus service.

On June 13, 2023, Indian Trail Town Council voted to contribute funding for the 74X route to Uptown Charlotte.

On Monday, June 19, 2023, the Union County Board of Commissioners voted to continue funding the 74X Union County Express bus service to the Town of Indian Trail. The 74X and will no longer serve the City of Monroe after September 29, 2023.



## 74X Union County Express – Indian Trail







Current funding level provides service to Indian Trail, NC.

If additional funding is provided, service past Indian Trail will be considered

# Independence Blvd. Busway Restoration

- Busway was closed in 2017 during construction of the Hawthorne Lane bridge for the Gold Line 2 streetcar project
- Was anticipated to remain closed while NCDOT converted the busway to a toll facility as part of the Independence Blvd widening
- NCDOT funding shortfalls delayed the busway conversion to toll facility
- ► In 2022, CATS requested funding to restore busway operation in interim period
- Project would modify entrance and exit of busway near Hawthorne Land Bridge
- ► NCDOT to manage and execute the work
- NCDOT Municipal Agreement
  - Approved in 2022
  - Original Estimated Cost \$750,000



## **Current Status**

NCDOT completed Final Design June 2023

Revised Cost Estimate \$1.3 million


- Design \$0.25 million
- Engineer's Estimate \$1.05 million
- Cost Increase due to higher unit prices and contractor shortages
- NCDOT Expressway Project currently scheduled to begin in 2028

Busway Use  $\approx$  4 years (minimum)



## **Busway Benefits**

- Independence Blvd Busway will be used by 5 CATS bus routes
  - Routes 40x, 46x, 51x, 64x and 74x
- Ridership declined during the pandemic, but since return to work last Spring average daily riders have increased
  - January 2022 85 to May 2023 259 (205% increase)
- Faster travel time (up to 15 minutes faster)
- Consistent travel time / improved reliability
- Increased transit ridership
- Highly visible / promotes benefits of transit investment
- Improves operational efficiency and reduces operating costs
  - Estimated Annual Savings: \$106K
