#### I. <u>Call to Order</u>

- III. Interim Charlotte Area Transit System Chief Executive Officer Introduction CTAG met Brent Cagle, Interim CATS CEO. Mr. Cagle provided a brief history of experience and his excitement for the opportunity to engage with this organization while the national search for a replacement CEO is underway.

    - Operating Budget Safety and Security is a priority
    - Employee Value Recruiting and Retaining
    - Creating a productive and rewarding culture
    - o Building Community Confidence
  - Captial
    - Midlife overhaul for rail cars
    - o Bus Replacements

#### VII. Other Business

- CTAG inquired of the new CEO search process. Brent Cagle share that Charlotte City Manager Marcus Jones/Assistant City Manager Liz Babson will update the MTC on the new CEO search. The recruitment is a national process with a minimum of 6 months or more as candidates are identified, vented and eventually one is selected for the covenant position.
- Paulus Ford Charlotte Area Transit System CEO's Executive Services Assistant/Citizens Transit Advisory Group's Advisor, reminded CTAG of the attendance requirements. Also, as a reminder that CTAG meetings are virtual except the September meeting when returning from summer break and the April meeting when recommending the proposed budget to the MTC for adoption.



































## Preliminary Capital Investment Plan
