#### 2. Project Overview

The Charlotte Area Transit System (CATS), a department of the City of Charlotte requests Proposals for the manufacture and delivery of transit buses ranging from 30 – 40 feet in accordance with the terms and conditions set forth in RFP 269-2023-1402. The estimated number of buses per year is 30. The Contract shall be a one-year term with four one-year options for renewal.

Buses are to be purchased in the following tiers; as pulled from the City of Charlotte Sustainable and Resilient Fleet Policy, as available and in following the City of Charlotte Strategic Energy Action Plan; Tier I - Zero emission vehicle Tier II - Alternative fueled internal combustion engine Tier III - Hybrid internal combustion engine Tier IV - Conventional internal combustion engine - Gasoline

Tier V - Conventional internal combustion engine - Diesel



#### **3. Preparation of Proposals**

#### Proposal Format Requirements (Sec. IP 12.3)

Proposals must be developed on the forms provided in this package and must follow the proposal content requirements in the order in which they appear in the proposal.

Package 1: Technical Proposal Requirements Package 2: Price Proposal Requirements Package 3: Qualification Package Requirements Package 4: Proprietary / Confidential Information





#### **3. Preparation of Proposals**

#### Proposal package:

- One original proposal
- Complete proposal on flash drive in searchable MS-Word or PDF format.





#### 4. Evaluation Criteria & Process

Proposals will consist of a technical proposal and a cost proposal and will be evaluated using the following criteria, listed in descending order of importance:

- Product Design and Performance;
- Manufacturer's Performance and Capabilities;
- Total Cost per Bus;
- Delivery Schedule





#### **4. Evaluations Criteria & Process**

- 6-member Evaluation Committee drawn from CATS staff
- During solicitation process, communicate with Procurement Officer only, contact with any other CATS staff is grounds for disqualification.
- CATS may advise Contractors of deficiencies in their proposal and request revised proposals and/or Best and Final Offers (BAFOs).
- CATS may request oral presentations/interviews with all Contractors or reduced range of highest ranked Contractors only.
- Select the proposal that best meets the evaluation criteria and is in the best interest of CATS. Final selection is made on a "best value" basis.
