#### **DESCRIPTION OF WORK:**

The Project is the Charlotte Mecklenburg Police Department's Northwest Division The building site is located at 1800 Mt Holly-Huntersville Rd., Charlotte, NC 28214. The Project consists of a new 16,000 square foot, single story facility. The scope includes, but is not limited to, the following:

The notary requirement is waived for bid bonds that are signed electronically.
