KEY POINTS:

• Every two years, the UNC-Charlotte publishes the Quality of Life Study, which analyzes quality of life variables in 173 Neighborhood Statistical Areas (NSA) within the City of Charlotte's boundaries and sphere of influence.

- The study assesses 20 local neighborhood variables representing **Social**, **Crime**, **Physical** and **Economic** dimensions.
- Utilizing statistical analysis, each NSA is classified as Stable, Transitioning or Challenged.
- The study is a relative assessment that compares NSAs to one another across the City.
- Below are the results of the 2006 Quality of Life Study rankings along with a comparison to the two previous studies.

Number of NSAs	2006	2004	2002	% Change
Rankings	Study	Study	Study	2002 -2006
Stable	89	92	100	- 11%
Transitioning	60	54	41	+46%
Challenged	24	27	32	-25%

- A spatial analysis shows Challenged NSAs, which have decreased, are primarily confined to the inner-city area. The growth of Transitioning NSAs has been in eastern, northern and western portions of the City. Stable NSAs, which have declined slightly, are primarily in the southern and outlying suburban areas.
- This year's study also provides an analysis of trends in NSA variables over the past four years. In each NSA, variables are shown as trending up, down or no change.
- The Neighborhood Quality of Life Studies help the City directs its resources and investments to areas of need as well as measures the results of its interventions.

• Copies of the 2006 Neighborhood Quality of Life Study will be distributed to Council at the workshop.

COUNCIL DECISION OR DIRECTION REQUESTED:

The study will be officially released to the public on September 5, 2006. Data from the study drives changes to the *HouseCharlotte* (Down payment Assistance) program, *Multi-Family Housing Locational Policy* and the *Neighborhood Matching Grant* program. Any proposed policy or programmatic changes to these programs will be placed on a future Council agenda.
