**TOPIC:** Six Year Crime Trends

**COUNCIL FOCUS AREA:** Community Safety

**RESOURCES:** Deputy Chief Kerr Putney

#### **KEY POINTS:**

- For police departments, long term crime trends are the most accurate performance indicator.
- In CMPD's jurisdiction, Part One crimes (homicide, rape, robbery, aggravated assault, burglary, larceny, vehicle theft, and arson) increased during the three year period from 2005 to 2007.
- From 2007 to 2010, Part One crimes decreased significantly, declining from 57,204 incidents in 2007 to 38,466 crimes in 2010.
- A number of strategies have been used to achieve this significant decrease in crime including:
  - o An organizational structure that places more officers in the field
  - Response Area Teams accountable for crime reduction in their assigned area
  - Emphasis on priority offenders/partnership with District Attorney's Office
  - Specialized units dealing with gangs, firearms, and assault with a deadly weapon
  - o Data driven enforcement and deployment strategies
  - o Emphasis on addressing precursors of crime
  - o Partnerships with federal, state, and local law enforcement agencies
  - o Citizen partnerships

#### **KEY POINTS:**

- In 2007, the state provided municipalities the authority to adopt ordinances and establish minimum standards of fitness for commercial structures and other non-residential buildings.
- In September 2009, the City Council approved the new Non-Residential Building Code (NRBC). Enforcement began on April 1, 2010.
- The intent of the NRBC is to ensure there are safe and sanitary commercial structures in our community.
- Staff will provide an overview of NRBC activities since implementation and assess its impact on the community.
