

June 9, 1937
Joint Board Meeting.

A joint meeting of the City Council and the Board of County Commissioners was held in the Mayor's office, City Hall, at 3:00 o'clock P. M., June 9, 1937, with Mayor Pro Tem Albea presiding, and the following present:

For the City: Councilmen Baxter, Durham, Griswold, Hovis, Hudson, Huntley, Little, Nance, Sides and Wilkinson.

For the County: Chairman Henry W. Harkey and Commissioners Cashion, Price and Wearn.

MEETING CALLED TO ORDER, AND PURPOSE STATED.

The meeting was called to order by Mayor Pro Tem Albea, who stated that the purpose of same was for the election of a Judge of the Juvenile and Detention Court, and the setting of the salary of the Judge.

ELECTION OF JUDGE.

Councilman Hudson, seconded by Councilman Griswold, moved that Judge Marion Redd be re-appointed to succeed himself.

Whereupon Commissioner Wearn moved that the election be by ballot, stating that the foregoing motion eliminated further nominations. No second, and after discussion, Commissioner Wearn stated that if no other nominations he would withdraw his motion.

Councilman Sides then moved that Judge Redd be re-appointed by acclamation. Motion seconded by Commissioner Wearn and unanimously carried.

The Chairman declared Judge Marion Redd re-appointed to succeed himself for a term of two years.

PERSONNEL OF COURT NOT SELECTED.

The election of the personnel of the Juvenile and Detention Court was held in abeyance until recommendations are received from Judge Redd.

SALARY OF JUDGE SET.

The question of setting the salary of the Judge was the next business in order, Commissioner Cashion advising that Judge Redd had asked the Budget Committee of the County Board to set same at \$4000.00 per year, but Commissioner Cashion stated that he was not in favor of this amount inasmuch as the other department heads were not receiving more than \$3600.00 and that he would only be in favor of any amount up to that sum.

Councilman Sides, seconded by Commissioner Cashion, moved that Judge Redd's salary be set at \$3600.00.

The question of the amount of salaries received by City of Charlotte Department heads was discussed, the fact being brought out that \$3600.00 was more than the City of Charlotte Department heads are receiving.

Whereupon, Councilman Hovis offered as a substitute motion that Judge Redd's salary be set at \$3000.00 per year. Motion seconded by Commissioner Price.

Councilman Sides, seconded by Commissioner Wearn, then moved that voting be by ballot. Ballots were prepared and the substitute motion of Councilman Hovis was voted on first. The following vote was recorded:

For the Motion	-	5-2/11 Votes
Against the Motion	-	3-9/11 "

The motion was declared carried and Judge Redd's salary was set at \$3000.00 per year.

ADJOURNMENT.

There being no further business to come before the Joint Board, on motion of Commissioner Wearn, seconded by Councilman Wilkinson, the meeting adjourned.
