The Chair recognized as a visitor Mr. A. M. Elliott, Principal of Alexander-Graham Junior High School.

MECKLENBURG ASSOCIATION OF LAW OBSERVANCE REPRESENTATIVES ASKED AID OF CITY IN LAW ENFORCEMENT.

Mr. D. E. Henderson, representative of the Mecklenburg Association of Law Observance, appeared before the Council and commended the City's officers for their attempt to bring about law enforgement in Charlotte and asked the City Council to work with the Police Department in rendering whatever help and encouragement needed to enter into a program to make Charlotte a cleaner and better place in which to live.

Mr. Henderson stated that up and down the City gambling and crime of all kinds are going on and that it might not be out of place for a full housecleaning in the city and county to strike at the higher-ups in crime who employ others to do the work while they reap the benefits.

At the conclusion of Mr. Henderson's remarks, Mr. Cole, Secretary of this Association, concurred in what Mr. Henderson had said and commended the Council for the stand it has taken.

OFFER MADE BY J. E. PENDLETON FOR OLD INCINERATOR PLANT BUILDING.

Mr. J. E. Pendleton, who made an offer of \$125.00 for the old Incinerator plant building, appeared before the Council and increased his former bid to \$135.00. Inasmuch as the Council last week decided not to sell this building, Mayor Douglas referred the offer to the Real Estate Committee for report next Wednesday.

MRS. MARY MASON LINK COMPLAINED OF SITUATION NEAR HER HOME.

Mrs. Mary Mason Link, a resident of Lexington Avenue, appeared with complaint that trucks of a newr-by dye plant kept the curbing of her drive-way torn up and that she had fallen several times and asked what could be done in order to stop this practise. Mayor Douglas stated that he would have the matter investigated in an effort to have the condition remedied.

Mr. J. B. Marshall, City Manager, reported that he had employed Mrs. Neal Hood as a clerical worker in the Health Department.

Mr. Marshall read a letter from the Salvation Army extending an invitation to the Mayor and City Council to the dedication of the Salvation Army Building on Friday Afternoon, September 17th., at 3:00 o'clock, at which time Governor Hoey will speak.

Mayor Douglas alsoncalled to the attention of the Council that Governor Hoey will speak at the Constitution Day Luncheon at the Chamber of Commerce on that same date.

EXPENSES OF CHAIRMAN C. C. BEASLEY TO CIVIL SERVICE ASSEMBLY IN OTTAWA, CAN.

On motion of Councilman Baxter, seconded by Councilman Hovis and carried, an appropriation of \$200.00 was made from the Contingent Fund to cover the expenses of the Chairman of the Civil Service Commission, Mr. C. C. Beasley, to the Civil Service Assembly in Ottawa, Canada, October 4th. through 7th.

COMMITTEE ON COURT HOUSE PARKING NOT READY TO REPORT.

Councilman Baxter stated that his committee was not yet ready to report on the question of two-hour parking in the vicinity of the law Building and Court House.

Mr. Marshall advised that Chairman Harkey of the Board of County Commissioners had called on him and advised that his Board had passed a resolution that the Chairman request the City to change parking on Myers Street from the East side to the West side and to mark off a place in front of the Welfare Building for the case-workers' cars. Mr. Baxter stated he would see Mr. Harkey regarding this before making the above report.

REPORT OF COMMITTEE ON KENDRICK SEWER.

Councilman Wilkinson, Chairman of the Public Works Committee, reported with regard to the request of Mr. Z. V. Kendrick for cancellation of sewer tax on his property on Cleveland Court, that after studying this for two weeks and on advice of the City Attorney, this Committee did not see how it could grant Mr. Kendrick's request of not charging sewer tax and that it recommended that this tax continue to be charged as in the past.

MR. GRADY GOODE PROTESTED CLOSING OF CONCESSIONS AT CARNIVAL SPONSORED BY D.A.V.

Mr. Grady Goode appeared before the Council, stating that he had not been authorized by the Disabled American Veterans' to appear and make the statement he was going to make, but that inasmuch as he had secured the permit for the D.A.V's to sponsor the Ideal Exposition Shows, he was appearing as an individual to protest the closing of the concessions at this carnival; that there were ten concessions that had not been allowed to open on orders of Mr. Hasty, City Solicitor. He stated that this carnival had been brought to Charlotte to aid disabled veterans, and that clean shows were promised and that it had not been determined that

these were gambling devices and asked why this carnival had been singled out for a gambling drive when gambling has been going on for years

Mayor Douglas assured Mr. Goode that the City had not purposely closed these concessions but that it was theduty of the Police Department to uphold the law and that it had no alternative when the Solicitor had regarded them to be contrary to the State law.

After Mr. Goode had left the Council Chamber, Councilman Wilkinson arose and made a motion that the City Council approve and uphold the action of the City Manager and the Police Department and request that they continue to carry out the law. This motion was seconded by Councilman Huntley and unanimously carried.
