Thereupon, Councilman Griswold moved that the Council do on record as disapproving of any more carnivals being held in the western part of the city, which motion was seconded by Councilman Durham and unanimously carried.

JUNIOR CHAMBER OF COMMERCE GRANTED USE OF ARMORY FOR TENNIS MATCH.

On motion of Councilman Baxter, seconded by Councilman Griswold, the Munior Chamber of Commerce was granted the use of the Armory-Auditorium for a tennis match on the night of May 14th., the proceeds from which are to be used to assist in the safety campaign recently conducted by the Junior Chamber.

EAST SECOND STREET TAKEN OVER FOR CITY MAINTENANCE.

On motion of Councilman Nance, seconded by Councilman Huntley, the request of Mr. H. B. Keller that the City take over for maintenance East 2nd. Street, from Myers Street 150 feet towards McDowell Street, was granted.

WATER SERVICE ON TUCKASEEGEE ROAD.

Kirkland, in the sum of \$9.80 covering labor and material for repairing the plaster damage caused by defective roof, and of the Wearn Lumber Company, \$2.67, for lumber and materials used in repairing stairway.
