MINUTES OF MEETINGS OF JULY 19TH AND 21ST READ AND APPROVED.

On motion of Councilman Baxter, seconded by Councilman Huntley and carried, the minutes of the meetings of July 19th and 21st were approved as read.

REQUEST FOR CHARITY LICENSE FOR MR. WM. REIVES.

Mr. H. Grady Goode appeared before the Council, requesting a charity license for Mr. Wm. H. Reives, who is a disabled war veteran, to operate a shoe repair shop. Mayor Douglas advised Mr. Goode that all charity licenses were handled through the Mecklenburg Welfare Association and the City would be glad to issue the license of recommended by this organization.

PURCHASE OF WATER METERS.

On motion of Councilman Huntley, seconded by Councilman Wilkinson and unanimously carried, contract was awarded to the low bidder, Pittsburgh Equitable Meter Company for 100 - 5/8" Water Meters, at a total delivered price of \$882.00, and the Mayor and Clerk were authorized to sign the contract.

On motion of Councilman Wilkinson, seconded by Councilman Hudson and unanimously carried, authority was given for the extension of a sewer on Carmel Street, to serve two houses, and estimated to cost \$162.80.

EQUIPMENT FOR DOMESTIC RELATIONS COURT.

City Manager Marshall read a letter from Mr. Henry Harkey, Chairman of the County Board of Commissioners, relative to the purchase of a Dictaphone for use in the Domestic Relations Court. This purchase was to be made jointly by the City and County, at a cost of \$369.00. On motion of Councilman Huntley, seconded by Councilman Baxter, and unanimously carried, this purchase was authorized.

REQUEST FOR PAVING ON HUNTLEY PLACE.

A letter from Mr. T. E. Hemby was read by the City Manager, requesting the City to construct sidewalks, curbing and gutters on Huntley Place, a new street between Providence Road and Cherokee Road. After discussion Councilman Baxter made a motion that the matter be referred to a Committee, appointed by the Mayor, and a report be made to the Council at the next meeting. The Committee named was Councilman Hovis, Baxter, and City Attorney Scarborough.

REQUEST FOR FREE USE OF ARMORY BY MORGAN RECREATIONAL COUNCIL.

On motion of Councilman Ward, seconded by Councilman Nance and unanimously carried, approval was given for the Morgan Recreational Council to use the Armory without cost for a dance, the proceeds to to towards a fund for a Community Center Building for use by the colored juveniles in the Cherry section of the City.

PURCHASE OF BONDS.

On motion of Councilman Nance, seconded by Councilman Hudson and unanimously carried, the City Treasurer was authorized to purchase five \$1,000.00 Mecklenburg County 4-3/4% bonds, due June 1, 1942, on 1% basis, subject to the approval of the Local Government Commission.

DISMISSAL OF FOOD INSPECTOR.

City Manager Marshall advised the Council that he had dispensed with the services of Mr. Chas. A. Clark, Food Inspector in the Health Department.

RECOMMENDATION RELATIVE TO EQUIPMENT FOR CHARLOTTE MEMORIAL HOSPITAL.

Mayor Douglas read a letter from Mr. P. C. Whitlock, Chairman of the Building Committee of the Memorial Hospital Association, in which he stated that the Committee had met and recommended to the City Council that contracts be let for certain equipment for the Hospital, as follows:

Group B - to Smith-Wadsworth Hardware Company as bid at \$1,583.00, the alternate to be accepted.

Group C - to John Van Range Company at \$1,104.28.

Group D - to Southern Equipment Company, through Fred Casey at \$1,274.25.

That the Committee recommended to the Council the rejection of all bids in Group E and F, and new bids be called for. Also, the Committee recommended to the Council that the City make application to the P.W.A. for a grant of 45% of the excess on building construction, which is understood to amount to \$51,864.00, with the understanding that the Memorial Hospital Association undertakes to put the City in funds to the amount of 55%.

RESOLUTION AWARDING CONTRACTS - CHARLOTTE MEMORIAL HOSPITAL.

The following resolution was presented and on motion of Councilman Hovis, seconded by Councilman Baxter, and unanimously adopted:
