'HIMUTES APPROVED.

Upon motion of Councilman Hinson, seconded by Councilman Johnston the minutes of the Special Meeting on February 6, 1946 were approved as read.

SALE OR LEASE OF OLD WATER WORKS PROPERTY REJECTED.

Councilman Newson reported that the Appraisal Committee had considered the request of the Carolina By-Products Company to purchase or lease the old water works property, near Andrill Terrace, and they recommended that the property be neither sold nor rented, but retained for the city's use. Motion was made by Councilman White that the recommendation be accepted. Motion seconded by Councilman Johnston, and unanimously carried.

DEFERMENT OF EQUIVALENT ELLIPSIATION REQUIREMENT OF COOPERATION AGREEMENT WITH HOUSING AUTHORITY GRANTED FOR ONE YEAR.

The City Manager advised that the Housing Authority has granted an extension of one year, to March 25, 1947, of the equivalent elimination requirement of the Cooperation Agreement between the City and the Authority.

CONTRACTS AND PURCHASES AUTHORIZED.
