NAME OF MONCURE STREET AUTHORIZED CHANGED TO MONCURE "DRIVE".

Upon motion of Councilman Albea, seconded by Councilman Smith, and unanimously carried, the name of Moncure "Street" was changed to Moncure "Drive" as requested by Mr. Ben Heath.

CONSTRUCTION OF SANITARY SEWER MAINS AUTHORIZED.

Motion was made by Councilman Albea, seconded by Councilman Whittington, and unanimously carried, authorizing the construction of sanitary sewer mains, inside the city limits, as follows:

- (a) Construction of 1,908 ft. of 8-inch mains and trunks, in Rolling-wood Subdivision, on request of Ervin Development Corp. at an estimated cost of \$6,290.00. A deposit of the entire amount has been received and is to be refunded as per terms of the agreement.
- (b) Construction of 1,570 ft. of 8-inch mains and trunks, in Illford Street, DeBenny Lane and Olinda Street, on request of Robert G. Powell, Agent, at an estimated cost of \$4,039.55. A deposit of the entire amount has been received and is to be refunded as per terms of the agreement.
- (c) Construction of 5,718 feet of 8-inch mains and trunks, in Shamrock Hills Subdivision, on request of C.D. Spangler Construction Co., at an estimated cost of \$24,665.00. A deposit of the entire amount has been received and is to be refunded as per terms of the agreement.
- (d) Construction of 2,945 ft. of 8-inch mains and trunks, in Blenwood Subdivision, on request of C. D. Spangler Construction Co., at an estimated cost of \$11,385.00. A deposit of the entire amount has been received and is to be refunded as per terms of the agreement.

CONDEMNATION PROCEEDINGS AUTHORIZED STARTED FOR RIGHT-OF-WAY ACROSS PROPERTY OF DR. J. S. DORTON.

Upon motion of Councilman Babcock, seconded by Councilman Dellinger, and unanimously carried, condemnation proceedings were authorized started for right-of-way across the property of Dr. J. S. Dorton for North Tryon Street sewer.

AIRPORT LEASES OF FAA BUILDING APPROVED.

Upon motion of Councilman Albea, seconded by Councilman Whittington, and unanimously carried, the following leases of FAA Building were approved:

- (a) Lease of FAA Building, Office space for 1,496 sq. ft., Feb. 16, 1960 to June 30, 1965, to FAA General Safety District Office, at a rate of \$3.50 per square foot per year, except for unheated storage space which is at the rate of \$1.50 per square foot per year.
- (b) Lease of FAA Building, Office space for 789 square feet, Feb. 23, 1960 to June 30, 1965, to FAA Airways Technical District Office, at a rate of \$3.50 per square foot per year except for unheated storage space which is at the rate of \$1.50 per square foot per year.

SUPPLEMENTAL AGREEMENTS BETWEEN CITY OF CHARLOTTE AND FAA ON EXISTING LEASES FOR ASR SITE AND HIGH INTENSITY APPROACH LIGHT SITE APPROVED.

Councilman Whittington moved that supplmental agreements between the City of Charlotte and FAA on existing leases for ASR site to 6/30/79 and High Intensity approach light site to 6/30/67 be approved. The motion was seconded by Councilman Myers and unanimously carried.

RENEWAL OF LEASE WITH ELECTRIC MAP CORPORATION AT AIRPORT, AUTHORIZED.

Upon motion of Councilman Albea, seconded by Councilman Smith, and unanimously carried, renewal of lease was authorized with Electric Map Corporation for 18 months from April 22, 1960 to October 22, 1961 and the city to receive 10% of gross income from the advertisers.

LEASE WITH TEL-O-TRONIC INDUSTRIES, INC. FOR "LISTENING POST" AT AIRPORT AUTHORIZED.

Councilman Whittington moved that lease be approved with Tel-O-Tronic Industries, Inc. for the installation of coin operated "listening posts" which the public can use to listen to the tower radio traffic, with the lease to run for a period of 2 years and City to receive 25% of gross. The motion was seconded by Councilman Albea, and unanimously carried.

TRANSFER OF CEMETERY LOTS AUTHORIZED.

Upon motion of Councilman Myers, seconded by Councilman Whittington, and unanimously carried, the Mayor and City Clerk were authorized to execute deeds for the transfer of the following cemetery lots:

- (a) Deed with Joseph S. Yike & wife, Frances R. Yike, for Lot 365, Section 4-A, Evergreen Cemetery, at \$126.00.
- (b) Deed with Edward J. Wannamaker, M.D. and wife, Mrs. Mary Stuart A. Wannamaker, for Lot 70, Section 2, Evergreen Cemetery, at \$320.00.
- (c) Deed with Mrs. Katherine O'D. Willis, for Lot 102, Graves 5 and 6, Section 3, Evergreen Cemetery, at \$80.00.

CITY MANAGER REQUESTED TO INVESTIGATE REGULATIONS CONTROLLING THE SPEED OF FREIGHT TRAINS TRAVELING THRU CITY.

Councilman Smith stated that he has received a report regarding the excessive speed of freight trains thru the city. That on Monday morning traffic had stopped at the crossing on Dowd Road to allow a train to pass. That after the first train passed, a car went across the tracks and was almost hit by a freight train going in the opposite direction at a speed of approximately 60 miles an hour. He requested the City Manager to investigate the regulations controlling the speed of trains and see that they are observed.

TRAFFIC ENGINEERING DEPARTMENT AUTHORIZED TO PURCHASE TRAFFIC SIGNAL TRUCK AT A COST OF \$4,500.00.

Mr. Veeder, City Manager, stated that the Traffic Engineering Department

has requested permission to purchase a new traffic signal truck to replace the one damaged in a traffic accident and for which the Insurance Company cannot make a settlement until all personal injury claims have been settled.

Upon motion of Councilman Babcock, seconded by Councilman Albea, and unanimously carried, the \$4,500.00 was authorized for the purchase of the Traffic Signal Truck.

POLICE CHIEF JAMES PERMITTED TO VISIT SCOTLAND YARD AT NO COST TO THE CITY OF CHARLOTTE.

Motion was made by Councilman Albea that Chief James be permitted to visit Scotland Yard, London, England for approximately ten days starting late in May for the purpose of obtaining ideas and information, said trip to be at no cost to the City of Charlotte. The motion was seconded by Councilman Whittington, and unanimously carried.

ADJOURNMENT.

Upon motion of Councilman Whittington, seconded by Councilman Albea, and unanimously carried, the meeting was adjourned.
