The City Council of the City of Charlotte, North Carolina met at 8:15 o'clock p.m., in the Council Chamber, City Hall in an adjourned meeting from the regular meeting on Monday, June 10, 1974, with Mayor John M. Belk presiding, and Councilmembers Fred D. Alexander, Kenneth R. Harris, Pat Locke, Milton Short, James B. Whittington, Neil C. Williams and Joe D. Withrow present.

MANPOWER DEPARTMENT ESTABLISHED AN ORDINANCE ESTABLISHING THE TABLE OF ORGANIZATION, REVENUES AND EXPENDITURES TO IMPLEMENT THE DEPARTMENT ADOPTED AND RESOLUTION AMENDING THE PAY PLAN OF THE CITY TO ASSIGN CLASSES ADOPTED.

Mayor Belk called the meeting to order at 8:15 o'clock p.m., and stated the purpose of the meeting is to discuss and establish a Manpower Department of the City.

Mr. Wiley Williams, Assistant City Manager, and Dr. David Travland, Director of Model Cities Department, explained the program, and answered the questions of Council.

After a lengthy discussion, Councilwoman Locke moved approval of the establishment of the Manpower Department, which motion was seconded by Councilman Alexander, and carried unanimously.

Councilman Harris requested that Councilmembers be furnished with monthly reports on this program.

Councilman Short moved adoption of Ordinance No. 209-X establishing the Table of Organization, Revenues and Expenditures to implement a Manpower Department for the City of Charlotte funded by the U.S. Department of Labor. The motion was seconded by Councilman Alexander, and carried unanimously.

The ordinance is recorded in full in Ordinance Book 21, at Page 71.

Upon motion of Councilman Alexander, seconded by Councilman Short, and unanimously carried a resolution amending the pay plan of the City of Charlotte as follows was adopted:

- (a) Class No. 441, Manpower Director, added and assigned to pay range 30, pay steps A through F inclusive.
- (b) Class No. 491, Program Operations Coordinator, added and assigned to pay range 23, pay steps A through F. inclusive.
- (c) Class No. 489, Program Development Coordinator, added and assigned to pay range 23, Pay steps A through F. inclusive.
- (d) Class No. 445, Manpower Counselor II, added to pay range 15, pay steps A through F. Inclusive.
- (e) Class No. 447, Manpower Counselor I, added to pay range 9, pay steps A Through F. Inclusive.

The resolution is recorded in full in Resolutions Book 10, at Page 9. ADJOURNMENT.

Upon motion of Councilman Harris, seconded by Councilwoman Locke and unanimously carried, the meeting was adjourned.
