BEGINNING at a concrete monument at the intersection of the northwesterly margin of Interstate Highway 85 and the southwesterly margin of Glenwood Drive and running thence with the new right-of-way of Glenwood Drive two courses as follows: (1) N. 10-45 E. 53.10 feet to a concrete monument; (2) N. 29-40 W. 250 feet, more or less, to a point in the northwesterly property line of Lot 6 as shown on a map recorded in Map Book 332, Page 246 in the office of the Register of Deeds for Mecklenburg County, North Carolina; thence with said property line S. 60-18 W. 409.44 feet to an old iron, the southwest corner of said Lot 6; thence S. 30-00 E. 290 feet to a point in the northwesterly margin of Interstate Highway 85; thence with said margin N. 60-18 E. 370 feet, more or less, to the BEGINNING.
