BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE: Section 1. That, Chapter 23, Article II, Section 23-43, of the City Code of the City of Charlotte be amended by having Building Zone Map of the Charlotte Perimeter Area amended by changing from Rural to Business 1, the following described property:

BEGINNING at a point in the easterly margin of Statesville Road, said point being the common front corner of Lots 4 and 5 in Block 2 as shown on a map of Kendrick property recorded in Map Book 3, Page 81 in the Office of the Register of Deeds for Mecklenburg County, North Carolina and running thence N. 73-31 E. 188.83 feet to the northeast corner of said Lot 4; thence S. 7-17 E. 67.65 feet, more or less, to a point in an existing Business 1 Zoning District boundary line; thence in a westerly direction with said line 182 feet, more or less, to the easterly margin of Statesville Road; thence with said margin N. 15-38 W. 28 feet, more or less, to the BEGINNING and being that part of Lots 3 and 4 in Block 2 of the aforementioned Kendrick Property not presently zoned for business purposes.

Section 2. That, this Ordinance shall become effective upon its adoption

after a public hearing in connection therewith.
