AMENDING CHAPTER 23, ARTICLE III.

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF CHARLOTTE TO PERMIT LIMITED COMMERCIAL USES IN CERTAIN MULTI-FAMILY AND OFFICE BUILDINGS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina.

Section 1. Chapter 23, Article III, of the Code of the City of Charlotte is hereby amended as follows:

- A. In Section 23-31, amend category (a) of the Table of Permitted Uses to include "Commercial uses in conjunction with certain multi-family and office buildings subject to regulations in Sec. 23-32.1" in R-6MF, R-6MFH, R-9MF, R-12MF, R-15MF, O-6 and O-15 Districts.
- B. In Section 23-31, amend Category (b) of the Table of Permitted Uses as follows: In the sentence beginning "Cafeterias and snack bars...", delete the words "accessory to and primarily", and add at the end of said sentence the words "subject to regulations in paragraphs (c), (d), (e), and (f) in Sec. 23-32.1".
- C. Immediately following Section 23-32, add a new section 23-32.1 as follows: "Sec. 23-32.1 Commercial Uses in Multi-Family and Office Buildings. Limited commercial uses may be established in conjunction with certain multi-family and office buildings in any Multi-Family Residential or Office District. The following requirements shall apply in addition to any other applicable requirements of this ordinance for the districts in which such uses are located.
 - (a) Allowable commercial uses shall be located only in a multifamily building having a minimum of 50 dwelling units or an office building having a minimum of 30,000 square feet of office space.
 - (b) Gross floor area used for commercial purposes shall be limited to 25 square feet per apartment in a multi-family building and 10% of gross floor area used for office purposes in an office building.
 - (c) Public entry to commercial facilities shall be from interior of building with no direct public entrance from street or outside of building permitted.
 - (d) No merchandise or merchandise display window shall be visible from outside the building.
 - (e) No outside storage or display of merchandise shall be permitted,
 - (f) No business or identification sign pertaining to commercial uses shall be visible from outside the building.
 - (g) Permitted commercial uses shall be limited to the following: In Multi-Family Residential and Office Districts - barber shops, beauty shops, laundry and dry-cleaning: pick up stations, restaurants, snack bars, and sundries shops. In Office Districts dispensing of drugs and flower shops."

Section 2. This ordinance shall become effective upon its adoption.
