

A RESOLUTION ORDERING THE MAKING OF  
CERTAIN LOCAL IMPROVEMENTS ON ROSEMONT  
AVENUE.

WHEREAS, the City Council has been petitioned, pursuant to the General Statutes and City Charter, to make improvements on Rosemont Avenue, and

WHEREAS, the City Clerk has certified the sufficiency of said petition and submitted same to the City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That said petition is duly signed by 86% of the number of owners, representing 91% of the lineal feet of frontage, of the lands abutting upon the proposed improvement and that said petition is hereby determined to be sufficient.
2. That Rosemont Avenue from Wilkinson Boulevard to the end at Hargrove Avenue, a distance of approximately 500 feet, be permanently improved by the installation of storm drainage facilities, base course and surface course.
3. That the maximum cost to be assessed upon the properties abutting the improvement shall not exceed \$2.50 per front foot and shall be assessed according to the extent of the respective frontage abutting upon the improvement by an equal rate per foot of such frontage.
4. That the property owners shall have the option of paying such assessment in cash within thirty (30) days from the first publication of notice of the assessment lien, without interest, or, if they should so elect and give notice in writing to the City within said thirty (30) days, they shall have the option of paying the assessment in not less than two or more than ten equal annual installments, with interest at the rate of six per cent (6%) per annum. The first installment with interest shall become due and payable sixty (60) days after the date of the confirmation of the assessment roll, and one subsequent installment and interest shall be due and payable on the same day of the month in each successive year until the assessment is paid in full.
5. That this resolution be published as required by law.

A RESOLUTION ORDERING THE MAKING OF CERTAIN  
LOCAL IMPROVEMENTS ON GALAX DRIVE, LEAFMORE  
DRIVE, CLINTWOOD STREET, AND BRAINTREE STREET

WHEREAS, the City Council has been petitioned, pursuant to the General Statutes and City Charter, to make improvements on Galax Drive, Leafmore Drive, Clintwood Street and Braintree Street, and

WHEREAS, the City Clerk has certified the sufficiency of said petition and submitted same to the City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That said petition is duly signed by 67% of the number of owners, who represent 74% of all the lineal feet of frontage, of the lands abutting upon the proposed improvement and that said petition is hereby determined to be sufficient.
2. That Galax Drive from Leafmore Drive to existing pavement, Leafmore Drive from Galax Drive to Clintwood Street, Clintwood Street from Leafmore Drive to Braintree Street, and Braintree Street from Clintwood Street to Galax Drive, a distance of approximately 1,568 linear feet, be permanently improved by the installation of storm drainage facilities and construction of roll type curb and gutter, base course and surface course.
3. That the entire cost of said improvements, exclusive of the cost as incurred at street intersections, shall be assessed upon the properties abutting the improvements according to the extent of the respective frontage thereon by an equal rate per foot of such frontage.
4. That the property owners shall have the option of paying such assessment in cash within thirty (30) days from the first publication of notice of the assessment line, without interest, or, if they should so elect and give notice in writing to the City within said thirty (30) days, they shall have the option of paying the assessment in not less than two or more than ten equal annual installments, with interest at the rate of six per cent (6%) per annum. The first installment with interest shall become due and payable sixty (60) days after the date of the confirmation of the assessment roll, and one subsequent installment and interest shall be due and payable on the same day of the month in each successive year until the assessment is paid in full.

WHEREAS, the City Council has been petitioned, pursuant to the General Statutes and City Charter, to make improvements on Tranquil Avenue, a city-maintained street, and

WHEREAS, the City Clerk has certified the sufficiency of said petition and submitted same to the City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That said petition is duly signed by 65% of the number of owners, who represent 59% of all the lineal feet of frontage, of the lands abutting upon the proposed improvement and that said petition is hereby determined to be sufficient.
2. That Tranquil Avenue from Chelsea Drive to Westfield Road, a distance of approximately 800 feet, be permanently improved by construction of standard curb and gutter.
3. That the entire cost of such improvements, exclusive of the cost as incurred at street intersections, shall be assessed upon the properties abutting the improvements according to the extent of the respective frontage thereon by an equal rate per front foot of such frontage.
4. That the property owners shall have the option of paying such assessment in cash within thirty (30) days from the first publication of notice of the assessment lien, without interest, or, if they should so elect and give notice in writing to the City within said thirty (30) days, they shall have the option of paying the assessments in not less than two or more than ten equal annual installments, with interest at the rate of six per cent (6%) per annum.
