An Ordinance Amending the City Code with Respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE: Section 1. That, Chapter 23, Section 23-8, of the Code of the City: of Charlotte is hereby amended by changing from O-6 to B-2 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at a point which is the intersection of a line which is parallel to and 300 feet north of Independence Boulevard and a line which is parallel to and 195 feet east of Eastway Drive, said point being also in the boundary line of an existing B-2 Zoning District and running thence N. 21 - 20 E. 112 feet, more or less, to the northwest corner of property owned by J. H. Canupp; thence S. 88-42 E. 501.73 feet; thence S. 4-49 E. 155 feet, more or less, to the existing B-2 Zoning District Line; thence with said Line N. 83-42 W. 550 feet, more or less, to the BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF CHARLOTTE TO STRIKE OUT PROVISIONS THEREIN REQUIRING OR REFERRING TO SEGREGATION BASED ON THE RACE OR COLOR OF PERSONS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. The Code of the City of Charlotte is hereby amended to strike out provisions therein requiring or referring to segregation based on the race or color of persons, as follows:

- (a) Section 7-9 of Article I, Chapter 7, is hereby repealed.
- (b) Section 7-28 of Article I, Chapter 7, is hereby amended by striking out the following words and commas, ", whether for the body of a white or colored person," appearing in lines one and two thereof.
- (c) Section 7-56 of Article II, Chapter 7, is hereby amended by striking out the following words, "and shall not be used for the burial of members of the colored race", appearing in lines three and four thereof.
- (d) Section 7-63 of Article III, Chapter 7, is hereby amended by striking out the following words, "and shall not be used for the burial of members of the white race", appearing in lines three and four thereof.
- (e) Section 11-2(b) of Article I, Chapter 11, is hereby repealed.
- (f) Section 13-11 of Article I, Chapter 13, is hereby amended by striking out the following words, "for both the white and colored races", appearing in lines thirteen and fourteen thereof.
- (g) Section 13-15(a) of Article I, Chapter 13, is hereby repealed.

Section 2. This ordinance shall become effective upon its adoption.
