An Ordinance Amending the City Code with respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE: Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9 to R-9MF on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at a point in the westerly margin of Lecline Drive, said point being the southeast corner of lot 6 in Block G of Eastwood Acres as shown on map recorded in Map Book 6, page 55 in the Office of the Register of Deeds for Mecklenburg County, North Carolina and running thence in a northerly direction with said margin of Lecline Drive 132.1 feet to a line which is parallel to and 124.9 feet south of the southerly margin of Furser Drive; thence in a westerly direction with said parallel line 216.2 feet, more or less, to the westerly property line of Lot 3 as shown on the aforementioned map; thence in a southerly direction with said property line 74.8 feet to the southwest corner of said Lot 3; thence in an easterly direction with the rear of Lots 3 - 6 as shown on the aforementioned map. 234.55 feet, more or less, to the BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.

AMENDING CHAPTER 13, ARTICLE I

AN ORDINANCE TO AMEND CHAPTER 13 OF THE CODE OF THE CITY OF CHARLOTTE TO REGULATE THE ADMITTANCE OF MINORS TO POOLROOMS AND BILLIARD PARLORS

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. That Chapter 13, Article I, of the Code of the City of Charlotte is hereby amended by adding thereto the following section:

"Sec. 13-5. No owner, manager, or person in charge of any poolroom or billiard parlor shall admit any minor under eighteen (18) years of age unless said minor shall be accompanied by his or her parent or legal guardian or shall have the written consent of his or her parent or legal guardian."

Section 2. A copy of this ordinance shall be conspicuously posted in every poolroom and billiard parlor having or required to have a city license.

Section 3. This ordinance shall become effective upon its adoption.
