RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHARLOTTE, CHARLOTTE, NORTH CAROLINA APPROVING UNDERTAKING OF SURVEYS AND PLANS FOR AN URBAN RENEWAL PROJECT AND FILING OF AN APPLICATION (PHASE 4)

WHEREAS, under Title I of the Housing Act of 1949, as amended (herein referred to as "Title I"), the Housing and Home Finance Administrator is authorized to extend financial assistance to local public agencies in the elimination and prevention of the spread of their slums and urban blight through the planning and undertaking of urban renewal projects; and

WHEREAS, it is desirable and in the public interest that the Redevelopment Commission of the City of Charlotte make surveys and prepare plans, presently estimated to cost approximately One-hundred-forty-thousand, seven hundred-eleven dollars (\$140,711.00), in order to undertake and carry out an urban renewal project of the character contemplated by Section 110 (c) of Title I, in that area proposed as an Urban Renewal Area, situated in the City of Charlotte, County of Mecklenburg and State of North Carolina, which is described as follows:

BEGINNING at the intersection of the northwesterly margin of South McDowell Street with the Northeasterly margin of Independence Boulevard; thence in a south-westerly direction with said margin of South McDowell Street to the intersection with the southwesterly margin of Ridge Street, or its westerly extension thereof as shown on Tax Map, City of Charlotte-Mecklen-burg County, N. C., Sheet No. 2-27, Dated January 1, 1952, Scale I" - 50'; thence with said margin of Ridge Street in a southeasterly direction to its dead-end and intersection with the rear line of properties fronting on Harding Place; thence in a northerly, northeasterly and southeasterly direction along the rear line of properties fronting on said Harding Place and Greenwood Cliff to its intersection with Sugar Creek; thence with Sugar Creek in a northerly direction to the northeasterly intersection of Independence Boulevard; thence with Independence Boulevard in a northwesterly direction to the place of beginning.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE

- 1. That the proposed Urban Renewal Area described above is a slum, blighted, deteriorated, or deteriorating area appropriate for an urban renewal project and the undertaking by the Redevelopment Commission of the City of Charlotte of surveys and plans for an urban renewal project of the character contemplated by Section 110 (c) of Title I in the proposed Urban Renewal Area is hereby approved.
- 2. That the financial assistance available under Title I is needed to enabel the Redevelopment Commission of the City of Charlotte to finance the planning and undertaking of the proposed project.
- That it is cognizant of the conditions that are imposed in the undertaking and carrying out of urban renewal projects with Federal financial assistance under Title I, including those prohibiting discrimination because of race, color, creed, or national origin and those relating to the relocation of site occupants and the provision of local grants-in-ad and the requirement that, as a condition to the execution of a contract for a loan or capital grant for an urban renewal project, the locality present to the Housing and Home Finance Administrator a workable program for community improvement as set forth in Section 101 (c) of Title I, for utilizing appropriate public and private resources to eliminate and prevent the development or spread of slums and urban blight; and that it is the sense of this body (a) that a feasible method for the relocation of families displaced from the urban renewal area, in conformity with Title I, can be prepared, and (b) that the local grants-in-aid can and will be provided in an amount which will be not less than one-third of the Net Project Cost of the Project and which, together with the Federal capital grant, will be generally equal to the difference between Gross Project Cost and the proceeds or value of project land sold, leased, or retained for use in accordance with the urban renewal

4. That the filing of an application by the Redevelopment Commission of the City of Charlotte for an advance of funds from the United States of America to enable it to defray the cost of the surveys and plans for an urban renewal project in the proposed Urban Renewal Area described above is hereby approved.
