

A RESOLUTION CONFIRMING THE ASSESSMENT ROLL
FOR LOCAL IMPROVEMENTS ON DALLAS AVENUE FROM
KELLY ROAD TO MONTAGUE ROAD.

WHEREAS, Dallas Avenue, from Kelly Road to Montague Road, has been improved by installation of storm drainage facilities and paving with base course and surface course, pursuant to a sufficient petition of owners of abutting property, and

WHEREAS, the City Council has approved the preliminary assessment roll for said improvements; has deposited same in the City Clerk's office for public inspection; has caused notice of hearing thereon to be published; and has held a public hearing thereon, all pursuant to the City Charter and the General Statutes of North Carolina,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That the preliminary assessment roll for improvements completed on Dallas Avenue, from Kelly Road to Montague Road, heretofore approved by Resolution adopted the 24th day of June, 1963, is hereby confirmed at 4:25 o'clock p.m., this 15th day of July, 1963, and is hereby made the final assessment roll for said improvements.
2. That the City Clerk is hereby directed to enter on the minutes of the City Council and the assessment roll, the date, hour and minute of the confirmation thereof and to deliver a copy of said assessment roll to the City Tax Collector for collection pursuant to law.
3. That, after the expiration of twenty (20) days from this date, the City Tax Collector shall cause to be published one time in some newspaper published in the city a notice that any assessments contained in said assessment roll may be paid in full to the City Tax Collector without interest thereon at any time before the expiration of thirty (30) days from the date of such publication, or, at the option of the property owners, to be exercised by giving written notice to the City Tax Collector within said thirty (30) days, may be paid in not less than two (2) or more than ten (10) equal annual installments, with interest thereon at six per cent (6%) per annum, the first installment to become due and payable on the date on which taxes are due and payable, and one subsequent installment with interest shall be due and payable in each successive year on the date on which taxes are due and payable until the assessment is paid in full.

RESOLUTION APPROVING AREA LOCATION OF SIX
HUNDRED UNITS OF LOW RENT DWELLINGS.

WHEREAS, on February 18, 1963, the City Council adopted resolutions determining that there exists a need for an additional six hundred units of decent, safe and sanitary low-rent dwellings and did therefore authorize the Housing Authority of the City of Charlotte to proceed with plans for the construction of such dwellings; and

WHEREAS, on February 22, 1963 the said Authority filed an application with the federal Public Housing Administration for a preliminary loan in connection with the proposed construction, which application has now been granted tentative approval;

NOW, THEREFORE BE IT RESOLVED, that the area location of the proposed 175 unit high rise apartment structure in the block bounded by North Poplar, North Church, West Ninth and West Tenth Streets, be, and it hereby is, approved; and

RESOLVE FURTHER, that the area location of the proposed 425 unit garden type apartment housing bound roughly by East Sixth, East Tenth, North Caldwell and North Myers Streets, be and hereby is approved.
