ON PETITION FOR LOCAL IMPROVEMENTS ON
WESTFIELD ROAD FROM HILLSIDE DRIVE TO
TRANQUIL AVENUE.

RESOLUTION FIXING DATE OF PUBLIC
HEARING ON PETITION FOR LOCAL
IMPROVEMENTS ON BAY STREET FROM
BASCOM STREET TO HANOVER STREET
