

A RESOLUTION DECLARING THAT PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE TAXICAB SERVICE PROPOSED BY THE APPLICATION OF BAKER CAB COMPANY, INC., FOR THE ISSUANCE OF NINE CERTIFICATES NOW HELD BY CHECKER CAB COMPANY, INC., AND SUBJECT TO AUTOMATIC REVOCATION UPON TRANSFER OF NINE TAXICABS TO BAKER CAB COMPANY, INC.

WHEREAS, the Baker/Company, Inc., has contracted to buy, and Checker Cab Company, Inc., has contracted to sell to said corporation, nine taxicabs for which certificates of convenience and necessity are now held by Checker Cab Company, Inc., and

WHEREAS, Baker Cab Company, Inc., has applied to the City Council for issuance of the nine certificates now held by Checker Cab Company, Inc., and subject to automatic revocation upon the sale of said nine (9) taxicabs, and

WHEREAS, the City Council has considered and investigated all matters pertinent to said application as required by Sections 19-9, 19-11, 19-12, and 19-18 of the Code of the City of Charlotte and, after notice and hearing as required by law, desires to approve said application,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, that it is hereby determined and declared that public convenience and necessity require the taxicab service proposed by the application of Baker Cab Company, Inc., and

BE IT FURTHER RESOLVED that, pursuant to Section 19-18 of the Code of the City of Charlotte, upon transfer of ownership of said nine (9) taxicabs, the nine (9) certificates held by Checker Cab Company, Inc., shall be automatically revoked and nine (9) new certificates shall be issued to Baker Cab Company, Inc., in the manner prescribed by the Code of the City of Charlotte.

RESOLUTION ORDERING THE MAKING OF
CERTAIN LOCAL IMPROVEMENTS ON
REMBRANDT CIRCLE

WHEREAS, the City Council has been petitioned to make improvements on Rembrandt Circle pursuant to the General Statutes and City Charter, and the City Clerk has certified the sufficiency of said petition and submitted same to the City Council, and

WHEREAS, the City Council has held a public hearing on said petition and now determines that said improvements should be made,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That said petition is duly signed by 66.7% of the number of owners, who represent 59.29% of all the lineal feet of frontage, of the lands abutting upon the proposed improvements and that said petition is hereby determined to be sufficient.
2. That Rembrandt Circle, from Randolph Road to Meadowood Lane, a distance of approximately 1,500 feet, be permanently improved by installation of storm drainage facilities, construction of roll type curb and gutter, and paving with base course and surface course.
3. That the entire cost of such improvements, exclusive of the cost as incurred at street intersections, shall be assessed upon the properties abutting the improvements according to the extent of the respective frontage thereon by an equal rate per foot of such frontage.
4. That the property owners shall have the option of paying such assessment in cash within thirty (30) days from the first publication of notice of the assessment lien, without interest, or, if they should so elect and give notice in writing to the City within said thirty (30) days, they shall have the option of paying the assessment in not less than two or more than ten equal annual installments, with interest at the rate of six per cent (6%) per annum. The first installment with interest shall become due and payable on the date on which taxes are payable, and one subsequent installment and interest shall be due and payable on said date in each successive year until the assessment is paid in full.
5. That this resolution be published as required by law.
