Such rates of tax are based on an estimated total assessed valuation of property for the purpose of taxation of \$785,000,000 and an estimated rate of collections of ninety-five percent (95%).

Section 4. There is hereby levied a poll tax of \$1.00 on all male persons between the ages of 21 and 50 unless exempt as provided by law, for the purpose of raising the revenue from poll taxes as set forth in the foregoing estimates of revenue, and in order to finance the foregoing appropriations.

Section 5. Copies of this ordinance shall be furnished to the City Treasurer and City Accountant to be kept on file by them for their direction in the disbursement of city funds.

Section 6. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 7. This ordinance shall become effective immediately upon its adoption.

An Ordinance entitled "1964-65 Budget Ordinance No. 257-X was introduced and Councilman Albea moved its adoption.

Councilman Smith requested that the record include the following: That the Contingency Fund on Charlotte Community Hospital is not voted as being passed to the hospital at this time, or at the discretion of the City Manager, but shall be brought back to Council for approval at such time the money is to be dispersed, and that the \$10,000 in the Traffic Engineer's lighting program is segregated and kept for the discretion of the Council; the purpose of this money being to light up areas that have a high incident of crime rate, hoping the lighting will help the Police Department in their efforts to curb crime.

Councilman Albea accepted the statement by Councilman Smith as part of his motion. The motion was seconed by Councilman Whittington, and unanimously carried.

AMENDING CHAPTER 20, ARTICLE IV

AN ORDINANCE AMENDING CHAPTER 20, ARTICLE IV, OF THE CODE OF THE CITY OF CHARLOTTE TO ADD A NEW SECTION 20-74 ESTABLISHING A PUBLIC OFF-STREET PARKING LOT.

WHEREAS, the City of Charlotte has purchased a tract of land bounded by East Fourth Street, South Alexander Street, South Davidson Street, and East Third Street for the purpose of constructing a governmental center which, when completed, will provide ample- off-street parking for the public in the City Hall-Police Station-Municipal Court area, but until such construction is begun the land will otherwise lie idle, and WHEREAS, in the interest of public convenience and necessity, there is a present need for an off-street parking lot to alleviate traffic congestion and inadequate public parking in said area,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte,

North Carolina:

Section 1. Chapter 20, Article IV, of the Code of the City of Charlotte is hereby amended by adding thereto the following new section:

Sec. 20-74. A public off-street parking lot is hereby established on land bounded by South Davidson Street, East Fourth Street, South Alexander Street and the City Employees' Parking lot.

Parking therein shall be regulated by parking meters requiring a deposit of ten cents for one hour and twenty-five cents for four hours.

Proper spaces shall be marked off and parking meters shall be installed containing information relative to parking time allowed and required deposit of coins. The hour of operation of the lot shall be from 7:00 A. M. to 7:00 P.M., 7 days a week. It shall be unlawful to park any vehicle in any space in this parking lot without making proper payment therefor as set forth herein.

Section 2. The preparation of this parking lot shall be by City employees and the costs thereof shall be paid from non-tax funds not otherwise appropriated.

Section 3. This ordinance shall become effective upon completion of the parking lot.
