AN ORDINANCE TO EXTEND THE CORPORATE LIMITS OF THE CITY OF CHARLOTTE, NORTH CAROLINA.

WHEREAS, THE City Council of the City of Charlotte North Carolina, has been petitioned under G.S. 160-452, as amended, to annex the area described herein, and

WHEREAS, the City Clerk has certified the sufficiency of said petition and a public hearing on the question of this annexation was held in the Council Chamber, in the City Hall, at 3 o'clock p.m., on the 14th day of September, 1964, and

WHEREAS, the City Council does hereby find as a fact that said petition meets the requirements of G. S. 160-452, as amended,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. By virtue of the authority granted by G. S. 160-452, as amended, the following described territory is hereby annexed and made part of the City of Charlotte, as the 14th day of September, 1964.

BEGINNING at a point in the Charlotte corporate limit boundary line, which point is South 5-1-2-50 East 978.56 feet from a City Limits marker at Plaza Road, and runs thence South 5-12-50 East and crossing the right of way of the American Telephone & Telegraph Company 1654.93 feet to a point in the center line of a branch, thence with the said line of said branch in eight courses as follows: (1) North 81-41-20 East 34.56 feet to a point, (2) North 41-15-20 East 37.91 feet to a point; (3) North 68-10-50 East 53.85 feet to appoint, (4) North 38-09-30 East 106.83 feet to a point, (5) South 58-32-20 East 89.10 feet to a point, (6) South 87-34-20 East 25.08 feet to a point, (7) South 66-09-50 East 137.09 feet to a point, and (8) South 44-11-20 East 8.00 feet to a point, thence North 43-06 East 59.64 feet to a point, thence North 16-41 East 263.64 feet to a point in the Center line of the American Telephone & Telegraph Company right of way, thence with the center line of said right of way North 80-11 East 158.0 feet to a point in the westerly margin of Barrington Road, thence in a northerly direction with said margin of said Road in four courses as follows: (1) with the arc of a circular curve to the left having a radius of 475.76 feet for a distance of 145.50 feet to aspoint, (2) North 10-10 West 173.0 feet to a point, (3) with the arc of a circular curve to the left having a radius of 4975.76 feet for a distance of 198.78 feet to a point and (4) North 12-18-20 West 261.68 feet to a concrete marker, thence North 57-36-30 West 470.80 feet to a concrete marker, thence North 42-56-40 West 361.30 feet to a concrete marker, thence North 52-49-10 West 51.41 feet to a point in the Charlotte City Limits line, the point of BEGINNING.

Being parts of land acquired by The Charlotte-Mecklenburg Board of Education by deeds recorded in the Mecklenburg County Public Registry in Books 2210 at page 191 and 2391 at page 285 as sites for the Cochran and Milton Road Schools.

Section 2. Upon and after the 1st day of July, 1965, the above described

territory and its citizens and property shall be subject to all debts, laws, ordinances and regulations in force in the City of Charlotte and shall be entitled to the same privileges and benefits as other parts of the City of Charlotte. The said territory is solely owned by The Charlotte-Mecklenburg Board of Education, a tax exempt agency of the State of North Carolina. Section 3. The Mayor of the City of Charlotte shall cause to be recorded in the Office of the Register of Deeds of Mecklenburg County, and in the office of the Secretary of State at Raleigh, North Carolina, an accurate map of the annexed territory, described in Section I hereof, together with a duly certified copy of this ordinance.

Section 4. This ordinance shall be published once, following the effective date of annexation, in a newspaper having general circulation in the City of Charlotte.

- (1) Striking the words "before the desk officer on duty at the police station" from lines 11 and 12 of subsection (a), and inserting in lieu thereof the words "at the office of the pleak of the municipal court."
- (2) Striking the words "before the desk officer on duty at the police station. The officer shall send one copy of such citation to the captain of the traffic division and shall retain one copy for himself". in lines 8, 9, 10 and 11 of subsection (b) and inserting in lieu thereof the words "at the office of the clerk of the municipal court. The officer shall send one copy of such citation to the clerk of the municipal court and shall retain one copy for himself."

Section 2. Chapter 20, Article VI, Section 20 13, of the Code of the City of Charlotte is hereby amended by:

- (1) Striking the words "chief of police" from the first line and inserting indicat thereof the words "clerk of the municipal court."
- (2) Striking the words "police department" from line 6 and inserting in lieu thereof the words "clerk of the municipal court."
- (3) Striking the words "police department" from line 10 and inserting in lieu thereof the words "clerk of the municipal court."

Section 3. Chapter 20, Arricle VI, Section 20-121 of the Code of the City of Charlotte is hereby amended by striking the words "police department" from the first line and inserting in lieu thesof the words "clerk of the municipal court."

Section 4. This ordinance shall become effective October 1, 1964.
