AN ORDINANCE AMENDING AND READOPTING AND CONTINUING IN FORCE CHAPTER 11, "LICENSES", OF THE CODE OF THE CITY OF CHARLOTTE TO PROVIDE FOR LEVYING, ASSESSING, IMPOSING AND DEFINING THE PRIVILEGE LICENSE TAXES OF THE CITY OF CHARLOTTE FOR THE FISCAL YEAR BEGINNING JULY 1, 1965, AND ENDING JUNE 30, 1966.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

<u>Section 1.</u> Chapter 11, entitled "Licenses," of the Code of the City of Charlotte is hereby amended as follows:

(1) By rewriting the first paragraph of Section 11-6 to read as

follows:

"Where the licensee begins a business or exercises a privilege, which is taxable under this chapter, after the expiration of seven (7) months of a current license year, then such licensee shall be required to pay only one-half (1/2) of the tax prescribed."

(2) By adding the following new subsection to Section 11-18 immediately following subsection (16), to be numbered subsection (16.1):

"(16.1) Auto and/or Truck Rental and/or Lease . . 37.50"

(3) By rewriting Section 11-18(152)(a) to read as follows:

"Manufacturers or wholesale dealers at one-fourth (1/4) of the amount levied by the State."

(4) By adding the following new subsection to Section 11-18 immediately following subsection (177), to be numbered subsection (177.1):

"(177.1) Lounge, Tap-Room, Bar or similar business . . 100.00"

(5) By adding the following new subsection to Section 11-18 immediately following subsection (197), to be numbered subsection (197.1):

"(197.1) Merchants - Wholesale and Retail Combined. Doing any kind of combined wholesale and retail business not herein specifically

taxed by this chapter shall pay for each such place of business the following graduated tax on annual gross sales:

(b) In excess of \$55,000.00 at the rate of 60¢ per thousand.

(c) See also chain stores."

(6) By striking out and deleting all of subsection (271) of Section 11-18.

Section 2. Chapter 11, entitled "Licenses," of the Code of the City of Charlotte, as amended by Section 1 of this ordinance, is hereby readopted and continued in force and as such constitutes the revenue ordinance of the City of Charlotte levying, assessing, imposing and defining the privilege license taxes of the City of Charlotte for the fiscal year beginning July 1, 1965, and ending June 30, 1966.

Section 3. This ordinance shall become effective upon its adoption.
