

ORDINANCE NO. 384-X

AN ORDINANCE TO AMEND ORDINANCE NO. 360-X, THE 1965-66 BUDGET ORDINANCE, AUTHORIZING THE TRANSFER OF A PORTION OF THE GENERAL FUND CONTINGENCY APPROPRIATION.

WHEREAS, the 1965-66 Budget Ordinance contained a Contingency Appropriation in the General Fund in the amount of \$80,813, of which \$24,779 remains; and


WHEREAS, the City Council and the Board of County Commissioners have agreed to finance a revised air pollution control program for the balance of the 1965-66 fiscal year and that each governing board appropriate half (\$8,238) of the total (\$16,476) required;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. That \$8,238 of the Contingency Appropriation in the General Fund is hereby appropriated to finance one-half the cost of a revised air pollution control program, to be administered by the Mecklenburg County Health Department, for the balance of the 1965-66 fiscal year.

Section 2. This ordinance shall become effective upon its adoption.

ORDINANCE NO. 385

AMENDING CHAPTER 13,  
ARTICLE I

AN ORDINANCE AMENDING CHAPTER 13, ARTICLE I OF THE CODE OF THE CITY OF CHARLOTTE BY ADDING A NEW SECTION REGULATING THE SALE TO MINORS OF MODEL GLUES CONTAINING SOLVENTS HAVING THE PROPERTY OF RELEASING TOXIC VAPORS; PROHIBITING THE ILLEGAL USE (COMMONLY KNOWN AS "GLUE-SNIFFING") OF SAID GLUES BY MINORS AND OTHERS; AND DEFINING MODEL GLUE.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina that:

Section 1. Chapter 13, Article I, of the Code of the City of Charlotte is hereby amended by adding a new section to be designated "Section 13-42" to read as follows:

"Section 13-42

"(a) Definition of Model Glue. As used in this ordinance the term 'model glue' shall mean any glue or cement of the type commonly used in the building of model airplanes, boats, and automobiles, containing toluol, hexane, trichlorethylene, acetone, toluene, ethyl acetate, methyl ethyl ketone, trichloroethane, isopropanol, methyl isobutyl ketone, methyl cellosolve acetate, cyclohexanone, or other solvent or chemical having the property of releasing toxic vapors.

"(b) Inhalation of Fumes Prohibited. No person shall, for the purpose of causing a condition of intoxication, euphoria, excitement, exhilaration, stupefaction, or dulling of the senses or nervous system, intentionally smell or inhale the fumes from any model glue; provided, however, that this section shall not apply to the inhalation of any anesthesia for medical or dental purposes.

"(c) Possession or Transfer for Unlawful Purpose Prohibited. No person shall for the purposes of violating or aiding another to violate any provision of this ordinance, intentionally possess, buy, sell, transfer possession, or receive possession of any model glue.

"(d) Use by Minors Regulated.

1. Except as provided in subsection (3) hereof, no person under 16 years of age shall possess or buy any model glue.

2. Except as provided in subsection 3 hereof, no person shall sell or transfer possession of any model glue to another person under 16 years of age.

3. Provided, however, a person may sell or transfer possession of model glue to a person under 16 years of age for model building or other lawful use where said minor has in his possession and exhibits the written consent of his parent or guardian. Provided, further, a person may sell and transfer possession of model glue to a person under 16 years of age where the glue is sold, delivered, or given away simultaneously with and as part of a kit used for the construction of model airplanes, model boats, model automobiles, model trains, or other similar models."

Section 2. This Ordinance shall become effective upon its adoption.
