

RESOLUTION CLOSING PORTIONS OF
CRISMAN STREET AND PACIFIC STREET
IN THE CITY OF CHARLOTTE

WHEREAS, a petition has been filed and received in accordance with the provisions of the General Statutes of North Carolina, Chapter 153, Section 9, subsection 17, and Chapter 160, Section 200, subsection 11, requesting the closing of certain portions of Crisman Street and of Pacific Street located in the City of Charlotte; and

WHEREAS, the City Council has caused to be published a notice of public hearing in accordance with the said Statutes; and

WHEREAS, said public hearing was held on the 5th day of April, 1965; and

WHEREAS, the petitioners, The Charlotte Coca Cola Bottling Company and Freedom Drive Investment Co., own all of the land adjoining the affected portions of Crisman Street and Pacific Street; and

WHEREAS, no persons or parties in interest have appeared in opposition to the closing of said portions of said Crisman Street and Pacific Street;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

That the City Council hereby orders the closing of portions of Crisman Street and Pacific Street as described below, it appearing to the satisfaction of the City Council that the closing of these portions of said streets is not contrary to the public interest and that no individuals, firm or corporation owning property in the vicinity thereof will be deprived of reasonable means of ingress and egress to his or its property:

1. THAT CERTAIN PORTION of Crisman Street extending from Freedom Drive to Pacific Street and being more particularly described as follows: Beginning at a point, the intersection of the southwesterly margin of Freedom Drive with the northeasterly margin of Crisman Street and running thence from said beginning point S. 50-31-00 W. 398.06 feet to a point; thence with the arc of a circular curve to the right with a radius of 142.99 feet an arc distance of 207.20 feet to a point; thence N. 46-27-30 W. 629.34 feet to a point, said point being the intersection of the southwesterly margin of Crisman Street with the southeasterly margin of Pacific Street; thence N. 50-31-00 E. 60.45 feet to a point, said point being the intersection of the northeasterly margin of Crisman Street with the southeasterly margin of Pacific Street; thence S. 46-27-30 E. 622.00 feet to a point; thence with the arc of a circular curve to the left, with a radius of 82.99 feet an arc distance of 120.26 feet to a point; thence N. 50-31-00 E. 390.72 feet to a point in the southwesterly margin of Freedom Drive; thence with the said margin of Freedom Drive S. 46-27-30 E. 60.45 feet to the point and place of Beginning.

2. THAT CERTAIN PORTION of Pacific Street extending from Crisman Street, southwesterly to the property of the Alexander Estate (now or formerly) and being more particularly described as follows: Beginning at a point, the intersection of the southwesterly margin of Crisman Street with the southeasterly margin of Pacific Street, and running thence from said beginning point S. 50-31-00 W. 464.18 feet to a point in the line of the Alexander Estate (now or formerly); thence with the line of the said Alexander Estate property (now or formerly) N. 46-27-30 W. 60.45 feet to a point, said point being the intersection of the northwesterly margin of Pacific Street with the northerly line of the Alexander Estate (now or formerly) property; thence N. 50-31-00 E. 464.18 feet to a point, said point being the intersection of the northwesterly margin of Pacific Street with the southwesterly margin of Crisman Street; thence S. 46-27-30 E. 60.45 feet to the point and place of Beginning.

BE IT FURTHER RESOLVED that a certified copy of this resolution be filed in the Office of the Register of Deeds of Mecklenburg County, North Carolina.

RESOLUTION FIXING DATE OF PUBLIC HEARING ON
PETITION TO CLOSE NORLINA STREET, SIXTH STREET
COURT (SUMMERVILLE ROW), AND PORTION OF NORTH
ALEXANDER STREET.

WHEREAS, the City of Charlotte entered into a Cooperation Agreement with The Housing Authority of the City of Charlotte, North Carolina, dated March 21, 1963, with respect to the construction of Housing Project NC 3-5; and

WHEREAS, the aforesaid Cooperation Agreement provides that the city will cooperate with The Housing Authority in closing the streets and alleys required to be closed in connection with the construction and development of the aforesaid project; and

WHEREAS, in accordance with the aforesaid Cooperation Agreement and pursuant to the further assurances given to it by a letter from Mr. William J. Veeder, dated November 5, 1963, the Housing Authority has requested the city to vacate and close all of Norlina Street and Sixth Street Court (Summerville Row) and that portion of North Alexander Street lying between East Sixth Street and East Seventh Street; and

WHEREAS, the procedure for closing streets as outlined in the North Carolina General Statutes, Section 160-200 (11) and Section 153-9 (17), requires a public hearing after notice to the abutting land owners not joining in the petition and after publication in a newspaper once a week for four consecutive weeks; and

WHEREAS, the city desires to fulfill its obligations for the closing of said streets as aforesaid;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte that a public hearing on the question of closing all of Norlina Street and Sixth Street Court (Summerville Row) and that portion of North Alexander Street lying between East Sixth Street and East Seventh Street shall be held at 3 p.m. on Monday, the 3rd day of May, 1965, in the Council Chamber of the City Hall. The City Clerk is hereby directed to publish such a notice in the Charlotte News once a week for four successive weeks next preceding the date fixed here for such hearing, as required by G. S. 153-9 (17).

A RESOLUTION DECLARING THAT PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE TAXICAB SERVICE PROPOSED BY THE APPLICANT OF BAKER CAB COMPANY, INC., AND AUTHORIZING THE ISSUANCE OF TEN (10) CERTIFICATES TO BAKER CAB COMPANY, INC., IN ACCORDANCE WITH THE CODE OF THE CITY OF CHARLOTTE.

WHEREAS, Baker Cab Company, Inc., has applied to the City Council for issuance of ten (10) certificates of public convenience and necessity for the operation of a like number of taxicabs, and

WHEREAS, the City Council has considered and investigated all matters pertinent to said application as required by Sections 19-9, 19-11, and 19-12 of the Code of the City of Charlotte, and after notice and hearing as required by law, desires to approve said application,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, that it is hereby determined and declared that public convenience and necessity require the taxicab service proposed by the application of Baker Cab Company, Inc., and

BE IT FURTHER RESOLVED that, subject to the conditions specified in Section 19-13 of the Code of the City of Charlotte, not more than ten (10) new and additional certificates of public convenience and necessity shall be issued to Baker Cab Company, Inc., provided that such certificates are activated within a period ending six (6) months from the date of adoption of this resolution.
