

A RESOLUTION AMENDING THE RESOLUTION ESTABLISHING AND REGULATING USE OF THE CITY EMPLOYEES' PARKING LOT.

WHEREAS, the City Council of the City of Charlotte, North Carolina, on July 13, 1964, adopted a resolution establishing and regulating the use of the City Employees' Parking Lot; and

WHEREAS, Section 1 thereof provides that the lot is established for the sole and exclusive use of City employees; and

WHEREAS, Section 2 thereof requires application and payment in advance of a fee of \$12.00; and

WHEREAS, members of certain boards, commission, committees and authorities serve without remuneration in the performance of their responsibilities in city government and are required to meet periodically at City Hall; and

WHEREAS, except for the City Employees' Parking Lot, there is inadequate parking in the City Hall area; and

WHEREAS, the City Council desires to permit the members of those boards, commissions, committees and authorities to park free of charge in the City Employees' Parking Lot when meeting at City Hall in the performance of their responsibilities;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That Section 1 of the resolution establishing and regulating use of the City Employees' Parking Lot, adopted July 13, 1964, is hereby amended, by inserting in line 6 thereof between the words "employees" and "whose" the words "and the members of those boards, commissions, committees and authorities who meet periodically at City Hall in the performance of their responsibilities in City government."
2. That Section 2 thereof is hereby amended by adding a new sentence as follows: "The Treasurer's Office is also authorized to issue such a parking permit, without charge therefor, to any member of those boards, commission, committees and authorities who meet periodically at City Hall in the performance of their responsibilities in City Government."

RESOLUTION AUTHORIZING CONDEMNATION PROCEEDINGS FOR ACQUISITION OF PROPERTY OF G. P. COVINGTON LOCATED AT 1016-18 E. 8TH STREET FOR NORTHWEST EXPRESSWAY

WHEREAS, the City Council finds as a fact that it is necessary to acquire certain property of G. P. Covington, located at 1016-18 E. 8th Street in the City of Charlotte for right of way purposes for the Northwest Expressway project; and

WHEREAS, the City has in good faith undertaken to negotiate for the purchase of this property but has been unable to reach an agreement with the owner for the purchase price;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte that, pursuant to Section 7.81, Chapter 713 of the 1965 Session Laws of North Carolina, condemnation proceedings are hereby authorized to be instituted against the property of G. P. Covington, located at 1016-18 E. 8th Street in the City of Charlotte under the procedures set forth in Article 9, Chapter 136 of the General Statutes of North Carolina, as amended; and

BE IT FURTHER RESOLVED that \$3,900.00, the amount of the appraised value of said property, is hereby authorized to be deposited in the office of the Clerk of Superior Court of Mecklenburg County, North Carolina together with the filing of the Complaint and Declaration of Taking.
