NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that the Superintendent of Building Inspection is hereby ordered to cause the demolition and removal of the dwelling located at 311 W. 7th Street in the City of Charlotte in accordance with the Housing Code of the City of Charlotte and Article 15, Chapter 160 of the General Statutes of North Carolina.

ORDINANCE NO. 442-X

AN ORDINANCE TO AMEND ORDINANCE NO. 360-X, THE 1965-66 BUDGET ORDINANCE, AUTHORIZING THE TRANSFER OF A PORTION OF THE GENERAL FUND UNAPPROPRIATED SURPLUS ACCOUNT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. That \$500.00 of the revenue in the General Fund unappropriated surplus account is hereby transferred and added to the appropriation made in the 1965-66 Budget Ordinance for the Traffic Engineering Department said amount then to be used for the purpose of installing traffic signal control equipment at the intersection of Oaklawn Avenue and Statesville Avenue.
