AMENDING CHAPTER 19, ARTICLE I, SECTION 19-26

AN ORDINANCE AMENDING CHAPTER 19, ARTICLE I, DIVISION 3, OF THE CODE OF THE CITY OF CHARLOTTE WITH RESPECT TO RATES OF FARE TO BE CHARGED BY TAXICABS.
