

RESOLUTION REAPPORTIONING ASSESSMENTS FOR LOCAL IMPROVEMENTS ON  
KILDARE DRIVE, FROM OLINDA STREET TO JOYCE DRIVE.

WHEREAS, Kildare Drive, from Olinda Street to Joyce Drive, has been improved by installation of storm drainage facilities and paving with base course and surface course, and a portion of said street has been further improved by construction of roll type curb and gutter along the frontage owned by Robert G. Powell, Jr., pursuant to a petition by Mr. Powell, one of the two owners of abutting property, requesting that the total assessment for the improvements be made against the property of said petitioner only; and

WHEREAS, the City Council on October 25, 1965, confirmed the assessment roll for said improvements, in the amount of \$3,305.56, the total of which was made against the property of petitioner; and

WHEREAS, Robert G. Powell, Jr., has subdivided his property and has requested that the assessment be apportioned to each of the lots of his new subdivision so that each lot will bear its proportionate share of the assessment; and

WHEREAS, a revised assessment roll has been prepared and filed in the City Clerk's office, showing the reapportionment of the total assessment;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That, at the request and with the consent of Robert G. Powell, Jr., the assessment against the property of Mr. Powell, heretofore confirmed by the City Council on October 25, 1965, is hereby reapportioned as shown on the revised assessment roll on file in the City Clerk's office.
2. That these reassessments shall include past installments of principal, interest and penalty, if any, and the remaining installments shall fall due on the same dates as they did under the original assessment.
