NOW THEREFORE, BE IT ORDAINED BY the City Council of the City of Charlotte, North Carolina, that the Supervisor of the Community Improvement Division of the Building Inspection Department is hereby ordered to cause the removal of said abandoned motor vehicle (s) located at 729 Belmont Avenue, Rear, Charlotte, N. C., in the City of Charlotte in accordance with Article 13-1.2 of the Code of the City of Charlotte and Chapter 160-200 (43) of the General Statutes of North Carolina.

AN ORDINANCE TO AMEND ORDINANCE NO. 655-X, THE 1967-68 BUDGET ORDINANCE, AUTHORIZING THE TRANSFER OF A PORTION OF THE GENERAL FUND CONTINGENCY ACCOUNT FOR THE CONSTRUCTION OF A GRAVEL SIDEWALK ON DORCHESTER PLACE.

ORDINANCE NO. 739-X

AN ORDINANCE TO AMEND ORDINANCE NO. 655-X, THE 1967-68 BUDGET ORDINANCE, AUTHORIZING THE TRANSFER OF A PORTION OF THE UNENCUMBERED BALANCE OF THE GENERAL FUND.

BE IT ORDAINED BY the City Council of the City of Charlotte, North Carolina:

Section 1. That \$20,000 of the unencumbered balance of the General Fund is hereby transferred to the appropriations made in the 1967-68 Budget Ordinance for Engineering-Engineering Division, said amount then to be used for design of Barclay Downs Widening from its intersection at Fairview Road to the entrance at Celanese Corporation with the intent of financing the construction of the facility at an early date.
