AMENDING CHAPTER 23, ARTICLE VII

AN ORDINANCE AMENDING CHAPTER 23 OF THE CODE OF THE CITY OF CHARLOTTE WITH RESPECT TO BUILDING PERMITS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. Chapter 23, Article VII, Section 23-87 of the Code of the City of Charlotte is hereby amended by deleting the provisions of subsections (a) and (b) of said section and inserting in lieu thereof the following:

- "(a) It shall be unlawful for any person to commence the construction, erection, repair, alteration, addition to, removal, moving or demolishing of any building or structure or part thereof, or to commence any excavation for such building or structure, without first making an application for and obtaining a building permit therefor from the superintendent of building inspection.
- "(b) The superintendent of building inspection shall not issue a building permit unless the plans, specifications and intended use of such building or structures or part thereof conform in all respects to the provisions of this chapter. The application for a building permit shall be accompanied by such information as the superintendent of building inspection may require to enable him to act upon such application. In cases where an applicant files an appeal from a decision of the superintendent of building inspection with respect to a matter governed by this chapter, or where he applies for a variance, the superintendent of building inspection shall forthwith transmit all the papers pertaining to the application to the board of adjustment for its action."

Section 2. Chapter 23, Article VII, Section 23-88 of the Code of the City of Charlotte is hereby repealed and deleted.

Section 3. This ordinance shall become effective upon adoption.
