BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9 to I-1 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at the southwest corner of property belonging to Mary Sample Hayes as described in Book 953, Page 300 of the Mecklenburg Public Registry, and running thence N. 12-11 E. 723.4 feet; thence S. 62-34-28 E. 900.34 feet; thence S. 30-10 W. 797.81 feet; thence N. 54-10-40 W. 679.25 feet to the BEGINNING.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9MF to B-1 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9 to B-1 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at the northeasterly corner of Lot 4 in Block 40 as shown on a plat recorded in Map Book 3, page 2 in the County Public Registry, and running thence N. 43-45-11 W. 70.84 feet; thence N. 44-46-35 W. 72.09 feet; to the easterly margin of Hawthorne Lane; thence with said easterly margin of Hawthorne Lane in a northerly direction 70.15 feet; thence S. 69-52-01 E. 211.69 feet; thence S. 14-55-30 W. 154.68 feet; to the southerly margin of Haywood Court; thence with said southerly margin three calls as follows:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9 to B-1 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

AN ORDINANCE TO AMEND ORDINANCE NO. 939-X, THE 1968-69 BUDGET ORDINANCE, AUTHORIZING THE TRANSFER OF FUNDS FROM THE CAPITAL IMPROVEMENT PROGRAM TO THE GENERAL BUDGET FOR THE PURCHASE OF PUMPING ENGINES.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1.
