An Ordinance Amending Chapter 23 of the City Code-Zoning Ordinance

An Ordinance Amending the City Code with respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from $\underline{R-9}$ to $\underline{B-2}$ on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

Beginning at the point of intersection of the northwesterly boundary of the land conveyed to petitioners by deed recorded in Book 1229 Page 320 in the Mecklenburg Public Registry (said line being the present zoning boundary between B-l and R-9 area) with the southerly right-of-way line of N.C. Hwy. #16-West (Belhaven Boulevard) and runs thence along said property and zoning boundary, S. 62-35 W. 187.05 feet to the easterly right-of-way line of Valleydale Road (Old N.C. Hwy. #16); thence along that said line, S. 26-38 E. 143.0 feet; thence, N. 65-04 E. 280 feet to a point in the aforesaid southerly right-of-way line of N.C. Hwy. #16-West (Belhaven Blvd.); thence along that said line with the arc of a circular curve having a radius of 1524.05 feet to the right and in a westerly direction 180 feet, more or less, to the point of beginning.
