

RESOLUTION AUTHORIZING CONDEMNATION PROCEEDINGS FOR ACQUISITION OF PROPERTY OF GEORGE S. GOODYEAR, AN INDIVIDUAL, AND MARPASTA CORPORATION, LOCATED ON PARK ROAD, BETWEEN SENECA PLACE AND CORTLAND ROAD, FOR THE COLONIAL PARK APARTMENTS' SANITARY SEWER.

WHEREAS, the City Council finds as a fact that it is necessary to acquire certain property of George S. Goodyear, an individual, and Marpasta Corporation, located on Park Road, between Seneca Place and Cortland Road in the City of Charlotte, for a perpetual easement and right of way for a sanitary sewer in connection with a sanitary sewer system for the Colonial Park Apartments; and

WHEREAS, the City has in good faith undertaken to negotiate for the purchase of this property, but has been unable to reach an agreement with the owner for the purchase price;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, that, pursuant to Section 7.81 of the Charter of the City of Charlotte, as amended by Chapter 216, 1967 Session Laws of North Carolina, condemnation proceedings are hereby authorized to be instituted against the property of George S. Goodyear, an individual, and Marpasta Corporation, located at Park Road between Seneca Place and Cortland Road in the City of Charlotte, Mecklenburg County, under the procedures as set forth in Article 9, Chapter 136 of the General Statutes of North Carolina, as amended; and

BE IT FURTHER RESOLVED that \$195.10, the amount of the appraised value of said property, is hereby authorized to be deposited in the office of the Clerk of Superior Court of Mecklenburg County, North Carolina, together with the filing of the Complaint and Declaration of Taking.
