is hereby amended as follows:

1 - Amend Article VII, Division 1, Sec. 23-88.1. Sign Permits, by deleting paragraph (c) in its entirety and subdtituting in lieu thereof the following:

(c) Sign permit fees shall be collected for each permit issued in accordance with the following schedule:

<u>Size of Sign Surface</u>	Fee
Up to 15 sq. ft.	\$3.00
Over 15 sq. ft. to 50 sq. ft.	4.00
Over 50 sq. ft. to 100 sq. ft.	6.00
Over 100 sq. ft. to 200 sq. ft.	9.00
Over 200 sq. ft.	12.00 "

2 - Amend Article VII, Division 1, Sec. 23-88.1. Sign Permits, by adding a new paragraph as follows:

"(d) Work requiring a permit, as described in Sec. 23-88.1. (a), that is commenced without securing the specified permit shall be subject to a late fee equal in amount to the fee shown in Sec. 23-88.1. (c). The late fee shall not be construed as a penalty, but as a charge for additional administrative expense."
